

<u>Article 120:</u>	<p>1. Peut constituer une marque tout signe représenté d'une manière graphique, lorsqu'un tel signe est susceptible de distinguer les produits d'une entreprise des produits d'une autre entreprise.</p> <p>3. Chaque fois qu'on mentionne dans la présente loi des: 3) marques falsifiées, on comprend par là soit des marques identiques utilisées illégalement, soit des marques qui ne peuvent pas être distinguées dans les conditions normales de commerce de celles qui sont déjà enregistrées pour les produits étreints par le droit de protection. 4) marques antérieures, on comprend des marques demandées ou enregistrées avec la priorité antérieure.</p>
<u>Article 122:</u>	<p>1. La disposition de l'article 120 paragraphe 1 n'exclut pas la reconnaissance comme marque un signe destiné à être utilisé simultanément par plusieurs personnes, y compris les entrepreneurs, qui en auraient fait collectivement la demande, qu'une telle utilisation ne soit pas contraire à l'intérêt public et n'ait pas pour objectif de tromper le public, en particulier en ce qui concerne la nature, la destination, la qualité, les propriétés ou la provenance des produits concernés (droit de protection collectif). 2. <u>Article 129¹</u>	<p>1. Article 137:	<p>1. Avant d'émettre la décision visée au paragraphe 1, l'Office des brevets par voie, forme et la langue prévue par l'Arrangement de Madrid ou le Protocole notifie leur refus avec indication de tous les motifs au Bureau international (refus de protection provisoire), et aussi fixe au titulaire un délai pour exposer sa position au sujet des preuves et matériaux rassemblés qui seraient susceptibles de témoigner de l'existence d'entraves à l'obtention du droit de protection.
<u>Article 152³:</u>	Lorsque l'absence de conditions légales pour obtenir sur le territoire de la République de Pologne le droit de protection d'une marque internationale pour les raisons visées à l'article 129 ¹ , ne concerne que certains produits l'Office des brevets prend la décision de refus de protection pour ces produits. La convention concernant la transmission du droit doit préciser les règles de l'emploi d'une telle marque, tel que cela est prévu dans le règlement décrit par l'article 122, paragraphe 2. 4. Le droit de protection d'une marque peut être transmis dans le cas de certains produits pour lesquels ce droit est accordé, si les produits pour lesquels la marque est accordée encore en faveur du cédant ne sont pas de même genre. Au moment de la transmission, ce droit est considéré comme indépendant du droit propre au cédant. 5. Cette obligation ne s'applique pas aux personnes domiciliées ou ayant leur siège social sur le territoire de l'Union européenne, états membres de l'Association européenne de libre-échange (AELE) – parties à l'accord sur l'Espace économique européen ou de la Confédération suisse.
<u>Article 244:</u>	1. Le déposant peut présenter une demande, conforme au code des procédures administratives, de réexamen de la décision de l'Office des brevets. 1.1. On applique pertinemment à la procédure de réexamen de la décision les dispositions de code des procédures administratives concernant l'examen d'un recours, sous réserve des paragraphes 1.2., 1.3., et 1.4. suivants: 1.2. La demande de réexamen de la décision nécessite une justification supplémentaire; 1.3. Le jugement est mené dans le cas mentionné dans l'article 89, paragraphe 2, du code des procédures administratives, là encore sur la demande du déposant; 1.4. Le Président de l'Office des brevets délègue un expert pour le réexamen de la décision. 3. Les dispositions des paragraphes 1. et 1.1., 1.2., 1.3. et 1.4. s'appliquent pertinemment aux résolutions.
<u>Article 248:</u>	La décision et la résolution de l'Office des brevets peuvent faire l'objet d'un recours de la part du déposant auprès de la Cour administrative.
<u>Article 254:</u>	Le jugement définitif de l'Office des brevetsachevant la procédure d'une affaire, mais en violation flagrante de la loi, peut faire l'objet d'une action en recours du président de l'Office des brevets, du Procureur général de la République de Pologne et du Médiateur auprès de la Cour administrative dans les 6 mois à compter de la date de notification du jugement en question à la partie.
<u>Article 315:</u>	1.
