(3) The Institute shall, through the International Bureau, send to the holder of an internationally registered trademark a notification of the provisional refusal and shall invite him to appoint a domestic representative.

(4) The representative referred to in paragraph (3) of this Article shall file with the Institute a power of attorney for representation within **four months** from the date of the notification of refusal.

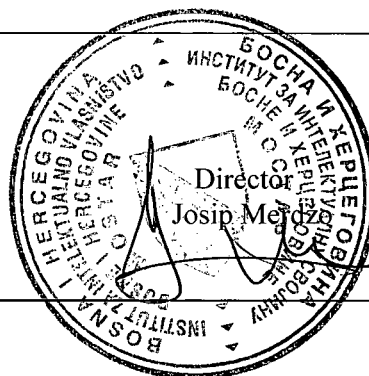

XII. Corresponding essential provisions of the applicable law:

Article 6

(Absolute grounds for refusal of registration of a trademark)

(1) the mark can not be protected by a sign:

- a) which is contrary to public order or morality,
- b) which can not be represented graphically,
- c) that is identical to the earlier mark or sign earlier record for the same goods or the same services,
- d) by its general appearance is not suitable for distinguishing the goods or services in trade for the goods or services for which registration was sought,
- e) which is composed exclusively of signs or indications that are used to indicate the kind, quality, quantity, intended purpose, value, geographical origin of products, time or goods or services production method or to highlight other characteristics of goods or services,
- f) consist exclusively of signs or indications which have become common in everyday life, in everyday or professional correspondence, or in the bona fide and established practices of the trade, to highlight certain types of goods or services,
- g), which is only a form of certain types of products or the shape of goods which is necessary to achieve a technical result, or the shape which gives substantial value to the product,
- h) by its appearance or content may mislead the public, particularly as regards the geographical origin, type, quality or other characteristics of goods or services,
- i) that contains or imitate official signs of control or quality assurance,
- j) which contains a national emblem or other official emblem, flag or emblem, name or abbreviation of the name of a country or an international organization, and their stimulation, except with the approval of the authorities competent country or organization,
- k) containing or imitating the name or abbreviation, emblem, badge, flag or other official sign of Bosnia and Herzegovina and its entities, cantons, districts, except with the approval of competent authority,
- l) represents or imitates a national or religious symbol,
- m) which is a sign for wine which contains or consists of a geographical indication which serves to highlight the wine or is a sign of a strong alcoholic drink which contains or consists of a geographical indication which is used for labeling alcoholic beverages, compared to wine or alcoholic beverages not to geographical origin,
- n) which is the origin of the name of a valid international registration for the territory of Bosnia and Herzegovina.

(2) sign under subsection (1) d) e) f) of this section may protect the brand if the plaintiff proves that by genuine use of the sign, it has become convenient to distinguish the movement of goods or services to which it refers.
