
VIII. Information relating to the possibility to request a review or file an appeal:

- (iii) Whether the request for review or appeal has to be filed in a specific language and/or through the intermediary of a representative whose address is within the territory of the Contracting Party:
The request has to be filed on English through the patent attorney of Turkmenistan
- (iv) Other requirements, if any: the indicated term will be extended at the request of the holder of the registration on condition that said request is filed before expiration of the term and the payment to the State Service on Intellectual Property under Ministry of Finance and Economy of Turkmenistan of the corresponding fees, the amount of which is 140 manat per month.
