As a result of *ex-officio* proceedings before the EUIPO and all proceedings having become final, the provisional refusal of the abovementioned mark is confirmed in part and the protection of the mark is partially refused for the European Union. The mark is therefore accepted for the following goods and services:

16 *Books; bookbinding material; printed matter; teaching materials [except apparatus]; works of art made of paper; art prints; printed periodicals in the field of figurative arts; graphic art books; bags [envelopes, pouches] of paper or plastics, for packaging; event albums; events programmes; origami folding paper; figurines made from paper.*

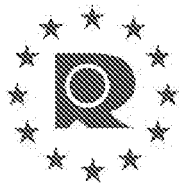
35 *Advertising; business management; business administration; clerical services; updating of advertising material; acceptance, processing and handling of orders [clerical services]; retail and wholesale services also via the Internet or mail order related to: origami books, origami folding paper, origami folding art, printed matter, computer equipment and peripherals; presentation of goods in communication media for the retail and wholesale trade; arranging and placing of advertisements; distribution of products for advertising purposes; sales promotion for others; dissemination of advertising matter; publication of printed matter [also in electronic form] for advertising purposes; arranging and conducting of advertising events.*

41 *Publication of printed matter and printed publications; publishing and reporting; publishing services; publishing services; publishing services, except printing; publication of instructional literature; publication of educational and training guides; conducting of instructional seminars; arranging, conducting and organisation of seminars; publishing services; electronic desktop publishing; origami Folding Art Exhibitions [lessons]; organization of Origami Folding Art Exhibitions [education]; organization of origami folding art exhibitions for entertainment purposes; multimedia publishing of electronic publications; publishing of journals; publication of magazines; publication of printed matter; publishing services for books and magazines; providing electronic publications; publication of newspapers,*

periodicals, catalogs and brochures; publishing services for periodical and non-periodical publications, other than publicity texts; arranging of workshops; arranging and conducting of workshops [training]; conducting courses, seminars and workshops; conducting of online correspondence courses; on-line publication of electronic books and journals (non- downloadable); electronic on-line publication of periodicals and books; providing on- line electronic publications, not downloadable; providing on-line publications.

The mark has been published pursuant to Article 190(2) EUTMR on **20/03/2019**.

Pursuant to Article 189(2) EUTMR and Article 79(2) EUTMDR, it shall have the same effect as the registration of a mark as a European Union trade mark.
