# Notification of a Provisional Partial Refusal of Protection (not based on an opposition) by the Intellectual Property Office

I have examined your designation under the Trade Marks Act 1994 and carried out a search of the relevant trade mark registers. Your designation does not appear to meet the requirements for Protection for the following reasons.

#### Retail

There is an objection under Section 1(1) and 3 (1)(a) against the following 'retail service'-type terms listed in your Class 35 specification:

"wholesale services for pharmaceutical, veterinary and sanitary preparations and medical supplies; retail services for pharmaceutical, veterinary and sanitary preparations and medical supplies"

These terms do not meet the legal criteria as set out by the Court of Justice of the European Union in the *Praktiker* case (see C-418/02). Our classification practice in respect of 'retail service'-type claims is set out in the current edition of the Trade Marks Manual (under the third section entitled 'The Examination Guide'). This objection may be overcome by amending the objectionable terms to the following:

"wholesale services **connected with the sale of** pharmaceutical, veterinary and sanitary preparations and medical supplies; retail services **connected with the sale of** pharmaceutical, veterinary and sanitary preparations and medical supplies"

# Search for earlier trademarks – for your information only

I have searched the relevant trade mark registers and found an earlier trade mark that I think you should be aware of. My initial view is that your trade mark and your services are similar to the earlier trade mark and their services. Therefore, the public are likely to confuse your trade mark with the earlier trade mark. This earlier mark is shown at the end of this report.

I am not refusing to accept your designation because of the earlier trade mark. Should you decide to proceed with your designation, I will not inform the owners of the mark that your designation will be published in our online journal. We do not notify holders of European Union Trade Marks (EUTM) or International Registrations (EU), which also have protection in the UK; this is for your information only

If you proceed, your designation will be published in the online Trade Marks Journal and anyone can oppose your designation should they have grounds to do so. If such action were to be successful, this would likely result in a costs award against you. Further information can be found on our website:

telemarketing services; negotiation and conclusion of commercial transactions for third parties"

The provisional refusal of all other services will then become final.
