## Notification of the Irish Patents Office of Total Provisional Refusal

Dear Sir/Madam,

This notification is issued pursuant to Article 5 of the Protocol relating to the Madrid Agreement concerning the International Registration of Marks and Rule 17(2) of the Common Regulations under the Agreement and Protocol, and is to inform you that protection for this mark is refused for the reasons set out below. Any references to Sections are to Sections of the Trade Marks Act, 1996 and to Rules are to Rules of the Trade Marks Rules, 1996.

## Section 8(1)(b)

The mark is devoid of distinctive character.

For a mark to possess distinctive character it must serve to identify the goods/services in respect of which protection is sought as originating from a particular undertaking, and thus to distinguish those goods/services from the goods/services of other undertakings.

It is contended that the mark, for which protection is sought, is incapable of performing the essential function of a trade mark, namely that of identifying the origin of the goods specified.

## Section 8(1)(c)

The mark consists exclusively of signs or indications which may serve in trade to designate the kind of goods in respect of which protection is sought. The wording should therefore remain free for all economic operators in that field to use.

## Section 10(2)

There exists a likelihood of confusion on the part of the public between the mark and the following earlier mark(s):

Class 11: Lighting apparatus and installations; lighting apparatus and devices for automobiles; light-emitting diodes LED lights; light emitting diode lights for automobiles; street lamps; safety lamps for underground use; germicidal lamps for purifying air; neon lamps; lanterns; dynamo lamps; fittings for discharge lamps; incandescent lamps; incandescent lamp fittings; ultraviolet ray lamps, not for medical purposes; germicidal lamps; chandeliers; water surface lamps; mercury lamps; aquarium lights; spotlights; arc lamps; safety lamps; diving lights; decoration lamps; infrared lamps; torches for lighting; fish gathering lamp; ceiling lights; fairy lights for festive decoration; electric lights for Christmas trees; standard lamps; searchlights; artificial solar lamp; floodlights; fluorescent lamps; flashlights torches; lights for motorcycles; automobile lights; reflectors for automobiles; lamps for directional signals of automobiles; electric bulbs for directional signals of automobiles; fluorescent lamp tubes; miniature light bulb; filaments for electric lamps; sockets for electric lights; headlights for automobiles; parts and fittings for all the

aforesaid goods.

Class 16: Paper; cardboard; printed matter; instructional and teaching material (except apparatus); apparatus for mounting photographs; graphic prints; graphic representations; graphic reproductions; luminous paper; periodical magazines; magazines (publication); manuals handbooks; newsletters; paper and cardboard; paper on which a hologram is formed; paper patterns; paper sheets (stationery); printed sheets on which a hologram is formed; stationery materials; stationery; teaching materials (except apparatus).

Class 42: Scientific and technological services, research and design relating to these services; lighting research, design and consultancy services; display screen research, design and consultancy services; research and development of electric power resources; research and development of solar batteries and solar battery modules; design of electrical power installations; research and development of home appliances.

- 2. This refusal is in respect of all of the goods for which protection is sought.
- 3. The holder may make representations in writing, or may request an extension of time for doing so, not later than *14 January 2020*. A request for an extension of time received after that date may be granted at the discretion of the Controller.
- 4. If representations or a request for an extension of time are not received by the specified date, protection of the mark will be refused.
- 5. Representations to the Controller or a request for a hearing in relation to this notification of refusal must be accompanied by an address for service within the European Economic Area as required by Rule 10(1)(a) as amended by Statutory Instrument No. 410 of 2010; failure to furnish such address will result in the holder being deemed to have abandoned his request for protection.
- 6. If, following the receipt of representations, it is considered that the requirements for protection are met, the mark will be published in the Official Journal and protection of it will be subject to opposition and observations by third parties. A refusal based on opposition or observations received may subsequently be issued.
