IX. Corresponding essential provisions of the applicable law:

#### Article 132 of the Industrial Property Code of Mozambique

1...The requirements for protection of a mark are:

- f) The applicant shall be notified of the provisional refusal within five days from the date of the decision.
- g) The applicant shall reply to the notice of provisional refusal within 30 days, failing which the refusal shall become final.

Article 134 Of the foresaid diploma (Grounds for refusal):

The following shall constitute grounds for refusal:

- a) "The lack of any of the elements in Articles 121, 122, 123 and 124 of this Code".
- X. Information relating to subsequent procedure
  - (i) Time limit for requesting review:30 Days from the date of receiving by the holder of the notification of provisional refusal.
  - (ii) Authority to which such request for review should be made: **Institute of Industrial Property.**
  - (ii) Indication concerning appointment of a representative:

    Its required that the representative must be Mozambican
