Extraits de la loi de la République de Lettonie sur les marques et indications géographiques, Loi, 16/06/1999

Article 18. Opposition à un enregistrement de la marque

(1) Dans les trois mois à compter de la date de la publication de la marque, les personnes intéressées peuvent, moyennant le paiement de la redevance applicable, présenter une opposition à l'enregistrement d'une marque. L'opposition doit être déposée auprès de la chambre de recours écrite, motivée par des arguments et références appropriées aux dispositions de la loi. Après l'expiration de ladite période, l'adversaire n'a pas le droit de modifier (élargir) la base juridique initiale de l'opposition, mais peut, jusqu'à la décision de la chambre de recours est adopté, soumettre des documents et des éléments supplémentaires qui confirmer (préciser) les faits sur lesquels est fondée l'opposition.

Article 39. Validité d'un enregistrement international en Lettonie

(5) L'opposition à l'entrée en vigueur d'un enregistrement international d'une marque en Lettonie, comme prévu à l'article 18 de la présente loi, doit être déposé dans les quatre mois à compter de la date de publication d'un avis d'enregistrement de la marque à l'égard de la Lettonie (extension territoriale à la Lettonie) dans le journal officiel de l'enregistrement international des marques.

Article 7. Marque antérieure en tant que motif d'invalidation de l'enregistrement

(1) L'enregistrement d'une marque peut être déclaré nul, en vertu des dispositions de la présente loi dans les cas suivants :

- 1) si elle est identique à une marque antérieure, et les produits ou services pour lesquels la marque a été enregistrée sont identiques à des biens ou des services à l'égard desquels la marque antérieure a été enregistrée ;
- 2) si, en raison de son identité ou de la similitude avec une marque antérieure appartenant à une autre personne et en raison de l'identité ou de la similitude des produits ou services respectifs, il existe un risque de confusion des marques de commerce ou d'un risque d'association entre les marques au nom des consommateurs concernés.
