

Grounds for refusal:  The presented trademark "CoreNRG" cannot be registered as a trademark, since its literal element "RG" is phonetically and graphically similar to the point of confusion with the: -literal and graphical element "RG" of the combined trademark "RG" № 448307, registered in the international register 02.11.1979 by Richter Gedeon Nyrt. (Gyömrői út 19-21 H-1103 Budapest) (HU) for the similar goods of the class 05; -literal and graphical element "RG" of the combined trademarks "RG GEDEON RICHTER" № 947644, 947645, 947646, registered in the international register 03.12.2007 by Richter Gedeon Nyrt. (Gyömrői út 19-21 H-1103 Budapest) (HU) for the similar goods of the class 05.
VI.	Corresponding essential provisions of the applicable law: Article 10.13 of the Law of the Republic of Uzbekistan «on Trade Marks and Service Marks and Appellations of Origin»
