I have examined your designation under the Trade Marks Act 1994 and carried out a search of the relevant trade mark registers. Your designation does not appear to meet the requirements for Protection for the following reason.

Indication relating to the kind of the mark

The holder of the mark has indicated that the mark is to proceed as a collective or certification mark. The designation is provisionally refused under Section 3(1)(a) of the Act. This is because the holder has indicated that the application filed is a CERTIFICATION/ COLLECTIVE/ GUARANTEE MARK.

Search for earlier trademarks – for your information only

If you proceed, your designation will be published in the online Trade Marks Journal and anyone can oppose your designation should they have grounds to do so.
