**NONFINAL OFFICE ACTION**

**Notice of Provisional Full Refusal**

**Deadline for responding.** The USPTO must receive applicant's response within six months of the "date on which the notification was sent to WIPO (mailing date)" located on the WIPO cover letter, or the U.S. application will be abandoned. To confirm the mailing date, go to the USPTO's Trademark Status and Document Retrieval (TSDR) database select "US Serial, Registration, or Reference No.," enter the U.S. application serial number in the blank text box, and click on "Documents." The mailing date used to calculate the response deadline is the "Create/Mail Date" of the "1st Refusal Note."

Respond to this Office action using the USPTO's Trademark Electronic Application System (TEAS). A link to the appropriate TEAS response form appears at the end of this Office action.

**Discussion of provisional full refusal.** This is a provisional full refusal of the request for extension of protection to the United States of the international registration, known in the United States as a U.S. application based on Trademark Act Section 66(a). See 15 U.S.C. §§1141f(a), 1141h(c).

The referenced application has been reviewed by the assigned trademark examining attorney. Applicant must respond timely and completely to the issue(s) below. 15 U.S.C. §1062(b); 37 C.F.R. §2.62(a), 2.65(a); TMEP §§711, 718.03.

**SEARCH OF USPTO DATABASE OF MARKS**

The trademark examining attorney searched the USPTO database of registered and pending marks and found no conflicting marks that would bar registration under Trademark Act Section 2(d). 15 U.S.C. §1052(d); TMEP §704.02. However, a mark in a prior-filed pending application may present a bar to registration of applicant's mark.

**I. PRIOR PENDING APPLICATION**

The filing date of pending U.S. Application Serial No. **88465777** precedes applicant's filing date. See attached referenced application. If the mark in the referenced application registers, applicant's mark may be refused registration under Trademark Act Section 2(d) because of a likelihood of confusion between the two marks. See 15 U.S.C. §1052(d); 37 C.F.R. §2.83; TMEP §§1208 *et seq.* Therefore, upon receipt of applicant's response to this Office action, action on this application may be suspended pending final disposition of the earlier-filed referenced application.

In response to this Office action, applicant may present arguments in support of registration by addressing the issue of the potential conflict between applicant's mark and the mark in the referenced application. Applicant's election not to submit arguments at this time in no way limits applicant's right to address this issue later if a refusal under Section 2(d) issues.

**II. SECTION 2(e)(1) REFUSAL - MERELY DESCRIPTIVE**

Registration is refused because the applied-for mark merely describes a feature of the applicant's goods. Trademark Act Section 2(e)(1), 15 U.S.C.

§1052(e)(1); see TMEP §§1209.01(b), 1209.03 *et seq.*

A mark is merely descriptive if it describes an ingredient, quality, characteristic, function, feature, purpose, or use of an applicant's goods. TMEP §1209.01(b); see, e.g., *In re TriVita, Inc.*, 783 F.3d 872, 874, 114 USPQ2d 1574, 1575 (Fed. Cir. 2015) (quoting *In re Oppedahl & Larson LLP*, 373 F.3d 1171, 1173, 71 USPQ2d 1370, 1371 (Fed. Cir. 2004)); *In re Steelbuilding.com*, 415 F.3d 1293, 1297, 75 USPQ2d 1420, 1421 (Fed. Cir. 2005) (citing *Estate of P.D. Beckwith, Inc. v. Comm'r of Patents*, 252 U.S. 538, 543 (1920)).

The applicant has applied to register “HEMPROLL” (special form) in connection with:

Class 16: *Tissue paper for makeup remover*

Class 34: *Cigarette paper*

Generally, if the individual components of a mark retain their descriptive meaning in relation to the goods, the combination results in a composite mark that is itself descriptive and not registrable. *In re Petroglyph Games, Inc.*, 91 USPQ2d 1332, 1341 (TTAB 2009) (holding BATTLECAM merely descriptive of computer game software with a feature that involve battles and provides the player with the option to utilize various views of the battlefield); *In re Cox Enters.*, 82 USPQ2d 1040, 1043 (TTAB 2007) (holding THEATL merely descriptive of publications featuring news and information about Atlanta where THEATL was the equivalent of the nickname THE ATL for the city of Atlanta); *In re Tower Tech, Inc.*, 64 USPQ2d 1314, 1317-18 (TTAB 2002) (holding SMARTTOWER merely descriptive of highly automated cooling towers); *In re Sun Microsystems, Inc.*, 59 USPQ2d 1084, 1085 (TTAB 2001) (holding AGENTBEANS merely descriptive of computer software for use in developing and deploying application programs on a global computer network).

Only where the combination of descriptive terms creates a unitary mark with a unique, incongruous, or otherwise nondescriptive meaning in relation to the goods is the combined mark registrable. See *In re Colonial Stores, Inc.*, 394 F.2d 549, 551, 157 USPQ 382, 384 (C.C.P.A. 1968); *In re Positec Grp. Ltd.*, 108 USPQ2d 1161, 1162-63 (TTAB 2013).

In this case, both the individual components and the composite result are descriptive of applicant's goods and do not create a unique, incongruous, or nondescriptive meaning in relation to the goods.

The definition of “hemp” is, “A fiber of hemp.” See attached evidence from Merriam-Webster. The attached evidence from the applicant's website, Farma Health, Google Patents, HempoilTalk, Pot Pocket, The Rocky Mountain Collegian, and Wikipedia show it is common for the material composition of the applicant's tissue paper or cigarette paper to be hemp fiber. Because it is common for the material composition of the applicant's goods to be hemp fiber, “HEMP” merely describes a feature of or is generic for the applicant's goods.

The definition of “roll” is, “Something that is rolled up into a cylinder.” See attached evidence from the Merriam-Webster. The attached evidence from the applicant's website, Amazon, and Uline show it is common for the applicant's goods to be sold as something that is rolled up into a cylinder. Because the applicant's goods are rolled up into a cylinder, “ROLL” merely describes a feature of or is generic for the applicant's goods.

The composite result “HEMPROLL” does not create a unique, incongruous, or otherwise nondescriptive meaning when used in connection with the applicant's goods. Essentially, the composite mark means paper comprised of hemp fibers that is rolled up into a cylinder. Because the composite mark does not create a unique, incongruous, or otherwise nondescriptive meaning when used in connection with the applicant's goods, “HEMPROLL” is refused registration on the Principal Register under Section 2(e)(1) of the Trademark Act.

Finally, the applied-for mark shows the wording in stylized lettering. Stylized descriptive or generic wording is registrable only if the stylization creates a commercial impression separate and apart from the impression made by the wording itself. See *In re Cordua Rests., Inc.*, 823 F.3d 594, 606, 118 USPQ2d 1632, 1639-40 (Fed. Cir. 2016); *In re Northland Aluminum Prods., Inc.*, 777 F.2d 1556, 1561, 227 USPQ 961, 964 (Fed. Cir. 1985); TMEP §1209.03(w). Common and ordinary lettering with minimal stylization, as in this case, is generally not sufficiently striking, unique, or distinctive as to make an impression on purchasers separate from the wording. See *In re Sadoru Grp., Ltd.*, 105 USPQ2d 1484, 1487 (TTAB 2012). In this case, the stylization of the wording does not create a commercial impression that is separable or apart from the wording itself. Because the stylization does not create a commercial impression that is separable or apart from the wording itself, the minor stylization does not overcome this refusal.

### **Generic Advisory**

In addition to being merely descriptive, the applied-for mark appears to be generic in connection with the identified goods and/or services. “A generic mark, being the ‘ultimate in descriptiveness,’ cannot acquire distinctiveness” and thus is not entitled to registration on either the Principal or Supplemental Register under any circumstances. *In re La. Fish Fry Prods., Ltd.*, 797 F.3d 1332, 1336, 116 USPQ2d 1262, 1264 (Fed. Cir. 2015) (quoting *H. Marvin Ginn Corp. v. Int'l Ass'n of Fire Chiefs, Inc.*, 782 F.2d 987, 989, 228 USPQ 528, 530 (Fed. Cir. 1986)); see TMEP §§1209.01(c) *et seq.*, 1209.02(a). Therefore, the trademark examining attorney cannot recommend that applicant amend the application to proceed under Trademark Act Section 2(f) or on the Supplemental Register as possible response options to this refusal. See TMEP §1209.01(c).

### **Supplemental Register Unavailable—Advisory**

Applicant cannot overcome the refusal by amending the application to the Supplemental Register, because a mark in an application under §66(a) of the Trademark Act is not eligible for registration on the Supplemental Register. Trademark Act Section 68(a)(4), 15 U.S.C. §1141h(a)(4); 37 C.F.R. §§2.47(c) and 2.75(c); TMEP §§801.02(b), 815, 816.01 and 1904.02(c).

Although applicant's mark has been refused registration, applicant may respond to the refusal(s) by submitting evidence and arguments in support of registration. However, if applicant responds to the refusal(s), applicant must also respond to the requirement(s) set forth below.

### **III. MARK DESCRIPTION OMITTED**

Applicant must submit a description of the mark, because one was not included in the application. 37 C.F.R. §2.37; *see* TMEP §§808.01, 808.02. Applications for marks not in standard characters must include an accurate and concise description of the entire mark that identifies all the literal and design elements. *See* 37 C.F.R. §2.37; TMEP §§808.01, 808.02, 808.03(b). In this case, the drawing of the mark is not in standard characters.

The following description is suggested, if accurate:

**The mark consists of the stylized wording “HEMPROLL”.**

### **IV. AMEND THE IDENTIFICATION OF GOOD TO AVOID DECEPTIVE REFUSAL—ADVISORY**

Applicant's mark includes the wording “HEMP”, which indicates that applicant's goods have and/or exhibit, (or will have and/or will exhibit) the following feature or characteristic: hemp fibers.

This feature or characteristic is considered desirable for applicant's goods because consumers find this material more appealing than traditional tissue paper or cigarette paper. However, if some or all of the goods do not (or will not) in fact have or exhibit this feature or characteristic, then registration may be refused because the mark consists of or includes deceptive matter in relation to the identified goods. *See* 15 U.S.C. §1052(a); *In re Budge Mfg. Co.*, 857 F.2d 773, 8 USPQ2d 1259 (Fed. Cir. 1988); TMEP §1203.02-.02(b).

To avoid such refusal, applicant may amend the identification to specify that the goods possess this relevant feature or characteristic. *See* TMEP §§1203.02(e)(ii), (f)(i), 1402.05 *et seq.* However, merely amending the identification to exclude goods or services with the named feature or characteristic will not avoid a deceptiveness refusal. TMEP §1203.02(f)(i).

Therefore, applicant may amend the identification to the following, if accurate:

Class 16: Tissue paper for makeup remover **comprised of hemp**

Class 34: Cigarette paper **comprised of hemp**

### **V. LICENSED U.S. ATTORNEY REQUIRED**

**Applicant must be represented by a U.S.-licensed attorney.** The application record indicates that applicant's domicile is outside of the United States in China, but no attorney who is an active member in good standing of the bar of the highest court of a U.S. State or territory has been appointed to represent the applicant in this matter. All applicants whose permanent legal residence or principal place of business is not within the United States or its territories must be represented by a U.S.-licensed attorney at the USPTO. 37 C.F.R. §§2.2(o), 2.11(a). Thus, applicant is required to be represented by a U.S.-licensed attorney and must appoint one. 37 C.F.R. §2.11(a). This application will not proceed to registration without such appointment and representation. *See id.* *See* [Hiring a U.S.-licensed trademark attorney](#) for more information.

**To appoint or designate a U.S.-licensed attorney.** To appoint an attorney, applicant should (1) submit a completed Trademark Electronic Application System (TEAS) ~~Revocation, Appointment, and/or Change of Address of Attorney/Domestic Representative~~ form and (2) promptly notify the trademark examining attorney that this TEAS form was submitted. Alternatively, if applicant has already retained an attorney, the attorney can respond to this Office action by using the appropriate TEAS response form and provide his or her attorney information in the form and sign it as applicant's attorney. *See* 37 C.F.R. §2.17(b)(1)(ii).

**Attorney email address required.** Applicant's attorney must provide his or her email address for the record. 37 C.F.R. §2.32(a)(4).

## Hemp tissue paper

### Abstract

In a product commonly used and known as toilet paper or toilet tissue, this invention is an improvement and yet distinctively different from the known product composed from the wood cellulose fibers of trees. This invention is constructed from the easily renewable resource of hemp cellulose fibers. The hemp cellulose fibers are derived mainly from the plants cannabis, cannabis sativa or cannabis sativa indica, however, also may be derived from the plants Abaca or Musa Textilis plant family (Manila hemp), Agave Sisalana (Sisal hemp) or various other hemp fiber producing plants. The hemp cellulose fibers are processed to a particulate pulp. The pulp is then formed into a thin sheet tissue paper product, of randomly oriented short hemp fibers, which is the invention. The invention is usually, but not necessarily, in the form of a long sheet of various widths and various lengths, depending upon the application, and perforated at intervals to ease dispensing. The sheet product may or may not have an added designed texture to the surface. The inventions is usually, but not always, formed into a roll around a hollow central core form of which the roll may be made of a sheet of single lamina (ply) or a sheet of multiple laminations (plies) of the invention. The invention may be in the form of other shapes, also in a single lamina (ply) or multiple laminations (plies) or (the invention, to facilitate other forms of dispensers. The invention is dispensed from the roll at the user's discretion to assist in one's removal of undesired residues) or fluids) from any portion of one's anatomy, someone else's anatomy, surfaces) or item(s). A person puts the invention to use by acquiring the desired amount of the invention (product) from whatever form of the product that the product has been shaped into to facilitate the dispenser. Once the desired amount is obtained one can form the product into numerous configurations in one's hand. After the user has configured the product as desired he or she rubs the product over the portion of his/her anatomy, or someone else's anatomy, or surface(s), or items) from which he or she wishes to remove the unwanted or uncomfortable fluids) or residue(s). The dispensed product may also be placed out flat with items) placed on - or wrapped in - to absorb or remove fluids) or residues) from the item(s).

### Description

#### SPECIFICATION

This invention relates to an article commonly known as toilet tissue paper that is generally used to extract the residues) or fluids) from one's anatomy, however, the invention may be used to facilitate one's removal of undesired residues) or fluids from surface(s), or item(s) generally found in the household or workplace. The invention may be formed into another shape commonly known as facial tissue paper to be put to uses such as to blow one's nose, wipe makeup off one's face, clean ears as well as many other uses. The use of the article is generally to facilitate one's removal of undesired residues) or fluid(s) from portions of one's anatomy or someone else's anatomy. The invention may also be formed into another shape commonly known as absorbent paper towel to facilitate one's removal of undesired residues) or fluid(s) from anatomies or surfaces) or item(s).

- 1) An absorbent soft tissue paper consisting of 100% hemp cellulose fibers.
- 2) An absorbent soft tissue paper as defined in claim 1 wherein the hemp cellulose fibers are randomly oriented.
- 3) An absorbent soft tissue paper as defined in claim 1 or claim 2 that is porous, flat (or slightly textured) and thin sheet to be packaged and dispensed in a dry form exhibiting dry, soft, and flexible consistency as well as high absorbent tendency that is less than 1 mm thickness.
- 4) A roll or sheet of absorbent soft tissue paper as defined in claim 1 or claim 2 or claim 3 and hereafter called hemp

So, what can these people do if they want the experience of a rolled blunt, but do not want the tobacco? As a smoker, I do not find this experience as enjoyable, when I want to enjoy a blunt, or anywhere near the same. Blunts and joints smoke and feel different when being smoked physically. It is a different type of high, different thickness of smoke, different drag, and basically, a joint can't not suffice the feeling of wanting to smoke a blunt, they are too different. Thankfully, there's a new way that those who prefer to stay away from tobacco can enjoy a blunt.

Recently, companies like High Hemp have created a 100 percent hemp blunt wrap. Even better, there is CBD in their blunt wraps! Other companies like Kong Wraps are doing the same thing. These blunt wraps come in various flavors, like normal blunt wraps, although not as many options. They have a similar style smoke to tobacco wraps, if not a better, smoother one. The wraps burn evenly, and do not canoe at all. The only down side when compared to a tobacco wrap is the difficulty of rolling one.

Hemp wraps are much harder to roll, and most do not have a glue strip like traditional tobacco blunts, so they can be harder to seal as well. The first few times you roll a hemp blunt, you are going to have to spend a bit more time with rolling than you normally would a blunt, but this time spent is well worth it.

Thanks to the CBD, the blunts are even more calming than normal marijuana, and much more so than tobacco blunts, since tobacco can be somewhat of a stimulant.

So next time you are looking to smoke a blunt, maybe try a hemp wrap, especially if you are not a tobacco smoker with the exception of blunts. This can then cut all tobacco out of your life, which is always a good thing.

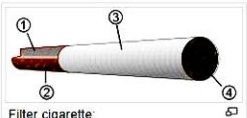

**Rolling paper** is a specialty paper used for making cigarettes (commercially manufactured filter cigarettes and individually made roll-your-own cigarettes). **Rolling papers** are packs of several cigarette-size sheets, often folded inside a cardboard wrapper.

## Composition [[edit](#)]

Cigarette paper is made from thin and lightweight "rag fibers" (nonwood plant fibers) such as flax, **hemp**, sisal, rice straw, and esparto. The paper is available in rolls and rectangular sheets of varying sizes, and has a narrow strip of glue along one long edge. It may be transparent, colored and flavored. It has a high filler content and a basis weight of 10-28 g/m². To control the smoking properties, this paper has a porosity that is suited to the type of tobacco and contains additives that regulate burning.<sup>[1]</sup> One critical paper characteristic is permeability; its primary physical influence is smoke dilution. Among the fillers used are calcium carbonate to influence the permeability and color, magnesium carbonate to improve ash color, or titanium oxide if a particularly white ash is required.<sup>[2]</sup> Sodium potassium tartrate (Seignette's salt), sodium and potassium citrate are used as a combustion regulator in cigarette paper, increased levels result in faster burning papers.<sup>[3]</sup> Poly(vinyl alcohol) in aqueous solution is used for cigarette adhesives.<sup>[4]</sup>

Permeability is defined as the measure of the volume of air that flows through a specified area of cigarette paper in a given unit of time. It is measured in CORESTA units. US commercial filter cigarette brands have paper permeability between 14 and 51 CORESTA units. Increased cigarette paper permeability results in increased smoke dilution with air.<sup>[5]</sup>

Other specialty papers for tobacco products are:

- Imitation cork paper is a brownish yellow colored paper used for the production of cigarette tips. It has an imitation cork imprint and joins the filter to the tobacco stick.
- Filter encasing paper is used for the production of acetate or cellulose filters. The tip paper may be covered with polyvinyl alcohol.<sup>[6]</sup>
- Cigar or cigarillo casing paper holds the chopped tobacco together and serves as the inner casing.

## Consumption [[edit](#)]

In the United States of America, Tobacconist Magazine has called roll-your-own (RYO) the tobacco industry's fastest growing segment. It estimates that 2-4% of cigarette smokers in the United States, or approximately 2.6 million people, make their own cigarettes. Many of these smokers have switched in response to increasingly high taxes on manufactured cigarettes.<sup>[7]</sup>

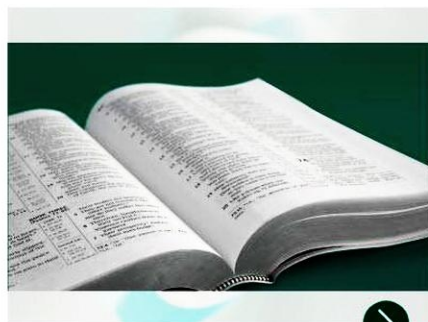
