Class 25: Clothing, footwear, headgear, blouses, sweaters / pullovers, shirts, combinations [clothing], suits, vests, jerseys [clothing], skirts, skorts, petticoats,leggings [pants]; sports jerseys, coats, pants, overcoats; parkas, bathrobes / dressing gowns, capes, shirt fronts, pocket squares, pyjamas, dresses, aprons [clothing], knitwear [clothing], tee-shirts, underwear, boxer shorts, jackets [clothing], embroidered clothing, clothing of leather or of imitations of leather, albs, kimonos, saris, sarongs, togas, turbans, veils [clothing], abayas, mantillas, furs [clothing], waterproof clothing, sweat-absorbent underwear, bathing trunks, bathing suits, hoods [clothing], gaiters, gloves [clothing], ski gloves, fingerless gloves, mittens, muffs [clothing], scarves / scarfs, sashes for wear, shawls, ties, ascots, hosiery, socks, slippers, stockings, tights, braces for clothing [suspenders], neck scarves [mufflers], sleep masks, uniforms, belts [clothing], money belts [clothing], bandanas [neckerchiefs], headbands [clothing], beach, ski and sport shoes; esparto shoes or sandals, sandals, wooden shoes; boots; ankle boots; hats, berets, caps being headwear, ski caps; bathing caps; shower cap; cap [headwear], ivy caps, ear muffs [clothing]; skull caps, taqiyah.

Class 26: Artificial flowers; badges (for wear) not of precious metal; beads other than for making jewelry; belt clasps; hair barrettes; bows for the hair; brooches [clothing accessories] not of precious metal; buckles [clothing accessories] not of precious metal; elastic bands, embroidery, buttons, hooks and eyelets for clothing and footwear; false hair; fastenings for clothing; hair bands; hair grips; decorative articles for the hair; hair extensions; hair nets; hair pins; lace for edgings; heat patches for repairing textile articles; needle cases;

numerals and letters for marking linen; ribbons; sewing needles; shoe buckles; shoe fasteners; shoe ornaments; shoulder pads for clothing; wigs; zip fasteners; embroidering crochet hooks; lace trimmings; hair curlers; lace and embroidery; hand-knitting needles; haberdashery, except yarns; hair coloring caps; hair curling papers; rug hooks; shoe laces; tapes for curtain headings; expanding bands for holding sleeves; spangles for clothing.

Class 35: Management of clothes, perfumes and accessories shops.

Class 42: Services in connection with beauty salons.
