Applied articles of Greek trademark law in case of notice of opposition ( Article 25 of law 4679/2020 and Article 140 of law 4072/2012):

- 1.The examiner's decision accepting the registration of application may be opposed within a three-month period as from its publication on the website of the General Secretariat of Commerce in accordance with par. 1 of Article 25, for a registration being contrary to one or more grounds of Article 4 & 5 of law 4679/2020.
- 2.If there are absolute grounds as per Article 4, the opposition can be filed by anyone who has a legitimate interest.
- 3.If there are relative grounds as per Article 5, the opposition shall be filed by the proprietors of earlier trademarks or rights, as well as by licensees authorized by the proprietors of those trademarks, according to the terms and conditions of Article 25 par.3.
- 4.The opposition shall be filed by a document submitted to the Trademark Office and the Administrative Trademark Committee shall be responsible for taking decisions in relation to it. It shall not be treated as duly entered until the opposition fee has been paid.
