VI. Grounds for refusal

43 (1) b, c

The mark consists of the words "HEALTH OF JOINTS IS IN RELIABLE HANDS", being a sign which may serve in trade, to designate the kind, purpose and other characteristics of the goods/services.

The mark is devoid of any distinctive character. It is considered that the words "HEALTH OF JOINTS IS IN RELIABLE HANDS" should be available for the other manufacturers in the relevant field to use and cannot be monopolized through registration as a trade mark.

VII. Information relating to the possibility to request a review or file an appeal:

(i) Time limit for requesting review or appeal:

The holder of the registration may request a review of the provisional refusal. The Slovenian Office must receive the request no later than 3 months \* from the date of this provisional refusal (the time limit starts from the date indicated under point IX). After a period the Office will issuing its final decision.

\*with the written request the deadline may be extended for 3 months
