If the holder does not contest the refusal within 3 months from the date of this notification, protection is given for:

Class 1: Chemicals used in industry, science, photography, agriculture, horticulture, forestry, soil fertilizers (natural and artificial), fire-extinguishing compositions, metal tempering and chemical soldering preparations, chemical substances for preserving foodstuffs, tanning substances, adhesives used in industry, unprocessed plastics, artificial and synthetic resins. Class 2: Paints, colorants, preservatives against rust and deterioration of wood, dyestuffs, mordants, natural resins, metals in leaf and powder form for painters and decorators. Class 4: Industrial oils and greases, lubricants, dust-binding compositions, fuel (including motor gasoline) and lighting fuel.

Class 5: Pharmaceutical, veterinary and sanitary products, dietetic substances for children and the sick, plasters, materials for dressings, material for stopping teeth and dental wax, disinfectants, preparations for weed and pest control.

Class 6: Common metals, unwrought and semi-wrought, and their alloys, anchors, anvils, bells, rolled and cast construction materials, metallic rails and other metallic materials for railway tracks, chains, non-electrical metallic cables and wires, locksmithing, metal pipes, safety boxes and chests, steel balls, horseshoes, nails and screws, ores.

Class 7: Machine tools, motors and engines (other than for land vehicles), transmission couplings and belts (other than for land vehicles), large agricultural implements, egg incubators.

VI. Grounds for refusal:

Absolute grounds:

Trademark Act Section 14 - The trademark is considered to be devoid of any distinctive character and/or it can be used in trade to designate the goods in question. It consists of signs or indications, which may serve to describe significant characteristics of the goods claimed in the international registration. The mark consists of the word COCO. COCO is short for coconut or coconut palm . When applied to "Bleaching preparations and other substances for laundry use, perfumery products, beauty products, soap products, make-up, essential oils, hair products, dentifrices" in class 3 and "tallow candles, candles, nightlights and wicks" it indicates a characteristic of the goods, namely that they contain or have a smell of coconuts. Consequently the mark needs to be kept free for commercial use for others, and must be refused for these goods.

Trademark Act Section 18 - The terms «other products of metal (non precious, not included in other classes)» in class 6, «machines» in class 7, «objects made thereof or coated therewith (excluding cutlery, forks and spoons) in class 14», «paper articles, cardboard articles» in class 16, «objects made thereof not included in other classes, and their products» in class

17, "goods made thereof not included in other classes" in class 18, "articles (not included in other classes) of wood, cork, reed, rush, wicker, horn, bone, ivory, whalebone, shell, amber, mother-of-pearl, meerschaum, celluloid and substitutes of all these materials or of plastic materials" in class 20, "repair services" in class 37, "treatment of materials" inclass 40, and the term "all miscellaneous services" in class 42 are considered too vague and / or are not sufficiently specified with regards to the goods or types of goods to which those goods and services relate. As the subject matter of the protection conferred is not adequately precise, the mark must be refused.

How to proceed:

The holder of the registration may request a review of the provisional refusal. The Norwegian Industrial Property Office must receive the request no later than 3 months from the date of this provisional refusal (The time limit is indicated under point VIII). Such request must provide an address of correspondence and be filed in Norwegian, Danish, Swedish or English. The Norwegian Industrial Property Office will respond in Norwegian. Please note that if The Norwegian Industrial Property Office, either subsequent to review or appeal, accept the designation of Norway, a post grant opposition may be filed against the mark within 3 months from the publication of the mark.

If the holder does not respond to this provisional refusal within the time limit, the international registration shall be considered abandoned in Norway for the goods/services that are excluded (Trademark Act Section 70 and 23). The international registration shall be resumed if the holder, within two months from the expiration of the time limit responds to the provisional refusal and pays the stipulated fee (NOK 550,-). Please note that The Norwegian Industrial Property Office does not send any notifications to the holder that the international registration is abandoned in Norway.
