**Notification of a Provisional Partial Refusal of Protection (not based on an opposition) by the Intellectual Property Office**

I have examined your designation under the Trade Marks Act 1994 and carried out a search of the relevant trade mark registers. Your designation does not appear to meet the requirements for Protection for the following reason.

**Absolute grounds for refusal**

**Section 3(1)(b) and (c)**

The designation is not acceptable in Classes 09, 16, 35 and 41. There is an objection under Section 3(1)(b) and (c) of the Act. This is because the mark consists exclusively of the word "IBIBLE" a sign which may serve in trade to designate the nature and intended purpose of the goods e.g. electronic book reader, software education service either in the form of an interactive bible or provided via interactive bible.

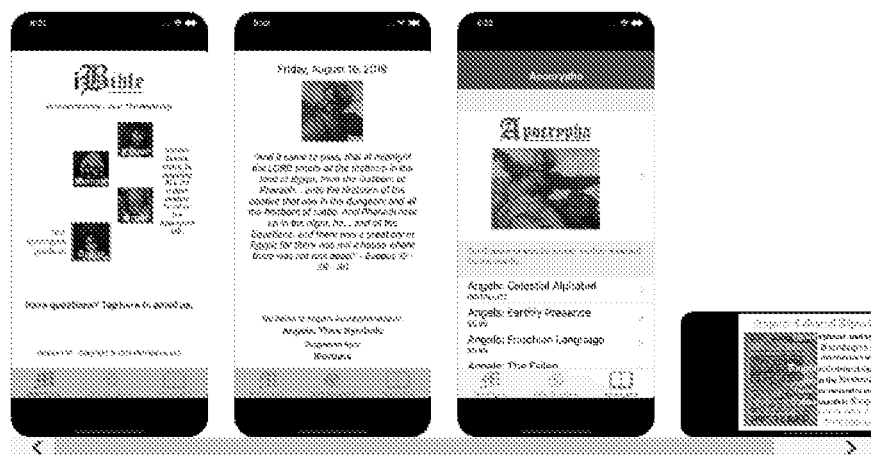

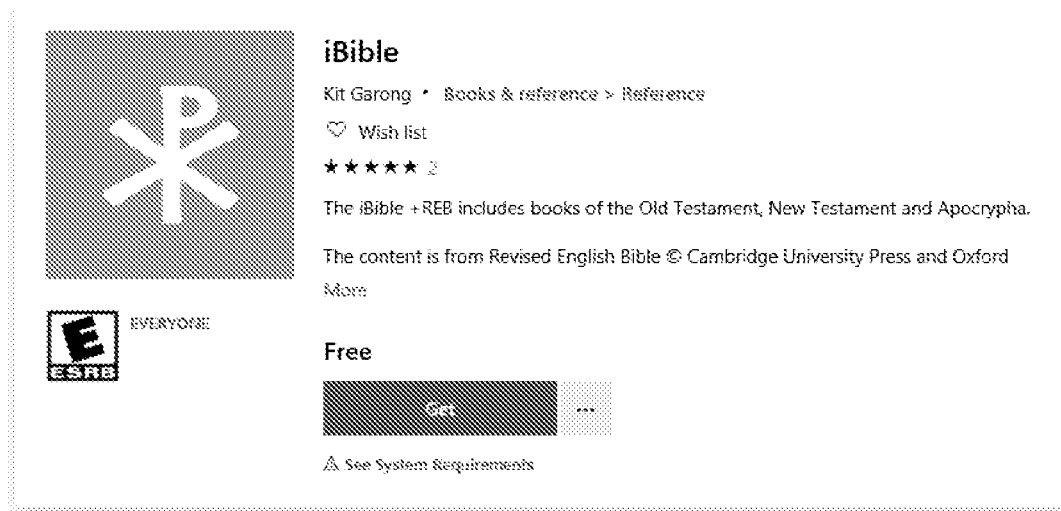

wholesale services for recorded and downloadable media, electronic notice boards, audio interfaces, road signs, luminous or mechanical, interfaces for computers etc.

These terms do not meet the legal criteria as set out by the Court of Justice of the European Union in the *Praktiker* case (see C-418/02). Our classification practice in respect of 'retail service'-type claims is set out in the current edition of the

This objection may be overcome by amending the objectionable terms to the following:

online retail services **connected with the sale of** downloadable and pre-recorded music and movies; online retail services for downloadable ring tones; online retail services **connected with the sale of** downloadable digital music; wholesale services **connected with the sale of** recorded and downloadable media, electronic notice boards, audio interfaces road signs, luminous or mechanical, interfaces for computers etc
