NOTICE OF OPPOSITION

We, Godiva Belgium B.V./S.R.L of Veeartsenstraat 42 D, B-1070 Anderlecht, Belgium (hereinafter referred to as 'the Opponent') hereby gives notice of our intention to oppose the registration of the Trade Mark, PURE BEAUTY LADY GODIVA (hereinafter referred to as 'the said Mark') advertised under the above number for Class 31 in Journal No. 2425 dated 25 November 2020 in the name of Hispalco, S.A. (hereinafter referred to as 'the Applicant').

The Grounds of Opposition are as follows-

- 1. The Opponent are manufacturers and merchants of, inter alia, chocolate and confectionery products.
- 2. The Opponent is the proprietor of the Trade Mark, GODIVA and of the following European and International Registrations:-

Mark: GODIVA

(hereinafter the 'Earlier Trade Marks').

The opposition is based on part of the goods and services indicated above in respect of which the Earlier Trade Marks are registered and is directed against all the goods for which registration is sought.

3. The Opponent has for many years extensively used the Earlier Trade Marks in connection with the aforesaid goods and services and the Earlier Trade Marks denote and have long denoted both to the trade and the public goods and services sold and supplied by it and distinguishes and has long distinguished such goods and services from the like goods and services of other traders.

- 4. The said Mark offends against the provisions of the Trade Marks Act 1996 and in particular, Sections 10 and 37.
- 5. The said Mark is similar to the Earlier Trade Marks and the goods or services for which registration is sought are similar to those for which the Earlier Trade Marks are protected to the extent that there exists a likelihood of confusion on the part of the public, which includes the likelihood of association of the said Mark with the Earlier Trade Marks and registration of the said Mark would offend against Section 10(2)(b) of the Trade Marks Act 1996.
- 6. The said Mark is similar to the Earlier Trade Marks and registration should be refused to the extent that the Earlier Trade Marks have a reputation in the State or the European Union and the use of the said Marks without due cause would take unfair advantage of, or be detrimental to, the distinctive character or reputation of the Earlier Trade Marks. Accordingly, registration of the said Mark would offend against Section 10(3) of the Trade Marks Act 1996.
- 7. The use of the said Mark in the State is liable to be prevented by virtue of any rule of law (including in particular, the law of passing off) protecting an unregistered trade mark or other sign used in the course of trade and registration of the said Mark would offend against Section 10(4)(a) of the Trade Marks Act 1996.
- 8. Registration of the said Mark is contrary to Council Directive No. 2015/2436/EC to approximate the laws of the Member States relating to Trade Marks.
- 9. The Opponent accordingly requests that the registration of the said Mark be refused at the exercise of the Controller's discretion and costs awarded to the Opponent.


