I am writing to inform you that following receipt of an opposition to the above trade mark, it is necessary to issue this formal provisional refusal letter. This provisional refusal covers all of the goods in class 25 of the International Registration.

This period cannot be extended, except in the circumstances described below. The holder should note that failure to file a TM8 will result in the provisional refusal being upheld.

If both parties to this dispute wish to negotiate and want to enter a 'cooling off period' then the time for filing the TM8 can be extended for a further seven months by the filing the form TM9c 'Request for a cooling off period, which is available at ipo.gov.uk/tmforms

The TM8 should be received on or before **27 July 2021** above unless a cooling off period is entered into by the parties.

The holder of the International Registration must provide us with an address for correspondence in the United Kingdom, (which for the purpose of the Act includes the Isle of Man, the Channel Islands and Gibraltar) on a form TM33

'Appointment or change of agent or contact address', which is available at <a href="mailto:ipo.gov.uk/tmforms">ipo.gov.uk/tmforms</a> within this two month period.

If one is not provided within this time, the international registration will be treated as withdrawn in whole or part.





2. The Opponent's Mark has a filing date which predates the filing date of the UK Designation of IR Number 1579478 Horse [logo] in Classes 20, 24 and 25 in the name of Hästens Sängar AB ("the Applicant's Mark"). As such, the Opponent's Mark constitutes an earlier mark within the meaning of Section 6(1) (a) of the Trade Marks Act 1994 ("the Act").

- 3. The Opponent's Mark consists of a Horse logo moving towards the right. The Applicant's Mark also contains of a Horse [logo] moving towards the right. The Opponent's Mark is referred to as a Horse [logo] and so is the Applicant's Mark. The Opponent submits that the Applicant's Mark is visually very similar and phonetically and conceptually identical and/or very similar to the Opponent's Mark. The Applicant's Mark is likely to be viewed by the average consumer as the name of a range of goods in Class 25 owned by, or connected or associated with, the Opponent. On this basis, the Applicant's Mark could serve to designate the same source of commercial origin as the Opponent's Mark.
- 4. This Opposition is directed against all of the goods applied for in Class 25 by the Applicant. The Opposition is based on all of the goods in Class 25 covered by the Opponent's Mark. The Applicant's Mark has been filed in respect of the following goods:

#### Class 25

Clothes, namely pyjamas, night gowns and robes; footwear, namely slippers and down socks; headwear, namely night caps and sleep masks.

The goods for which the Applicant's Mark has been filed in Class 25 are either identical and/or similar to the Opponent's goods in Class 25 because the Opponent's goods cover the broad terms clothing, footwear, and headgear.

- 5. The close similarity between the Applicant's Mark and the Opponent's Mark and the identity and/or similarity of the respective goods in Class 25 covered by the marks is such that there exists a high risk of confusion between them, including a likelihood of association. It is submitted that if the Registrar is so minded to not consider that direct confusion arises, applying the tests in L.A. Sugar Limited v By Back Beat Inc., Case BL-O/375/10, there would nevertheless at the very least be indirect confusion between the respective marks. The Applicant's Mark therefore contravenes Section 5(2)(b) of the Act.
- The relief claimed by the Opponent is the refusal of the Applicant's Mark in its entirety and an award of costs in these proceedings.
