NOTICE OF OPPOSITION

We, Bacardi & Company Limited, of Aeulestrasse 5, FL-9490 Vaduz, Liechtenstein (hereinafter "the Opponent"), hereby give notice of its intention to oppose the registration of the Trade Mark advertised under the above number in Class 33 in Journal No. 2444 dated 18 August 2021.

The Grounds of Opposition are as follows:-

- 1. The Opponent has for many years carried on business at the above address as producers and merchants of, inter alia, alcoholic beverages and vodka.
- The Opponent is the Proprietor of:
 European Union Trade Mark
 Registration No. 017563801

International Registration No. 0890134 designating the EU





Full particulars of the Opponent's Trade Marks are attached at Annex 1. These Trade Mark rights are collectively referred to as the "said Trade Marks".

- 3. The Opponent has for many years extensively used its said Trade Marks in connection with the aforesaid goods and the said Trade Marks denote and have long denoted both to the trade and the public goods of the Opponent and distinguishes and has long distinguished such goods from the like goods of other traders. The Opponent has built up significant goodwill and reputation in the said Trade Marks in the State.
- 4. The Mark applied for offends against the provisions of Section 10 of the Trade Marks Act, 1996.
- 5. The Mark applied for is similar to the Opponent's said Trade Marks and the goods for which registration is sought are identical or similar to those for which the Opponent's said Trade Marks are protected to the extent that there exists a likelihood of confusion on the part of the public which includes the likelihood of association. The Application offends against Section 10(2)(b) of the Trade Marks Act, 1996
- 6. The Mark applied for is similar to the Opponent's said Trade Marks and registration should be refused to the extent that the said earlier Trade Marks have a reputation in the EU and use of the Mark applied for without due cause would take unfair advantage of, or be detrimental to, the distinctive character or reputation of the said earlier Trade Marks. The Application offends against Section 10(3) of the Trade Marks Act, 1996.

- 7. The Mark applied for should be refused if, or to the extent that, its use in the State is liable to be prevented by virtue of the law of passing off having regard to our reputation/goodwill in the said Trade Marks acquired as a consequence of their use in the course of trade. The Application offends against Section 10(4)(a) of the Trade Marks Act, 1996.
- 8. Registration of the said Mark is contrary to Council Directive No. 89/104 EEC to approximate the laws of the Member States relating to Trade Marks.
- 10. The Application in respect of the said Trade Mark which the Applicant has applied to register ought in the discretion of the Controller of Intellectual Property to be refused and costs awarded to the Opponents.






