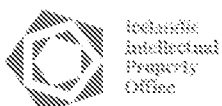
V. **Appeal (partial grant/refusal):**

The fee for appeal stipulated in Regulation on fees for Patents, Trademarks and Designs etc. must be paid within the same time limit.
