Discussion of provisional full refusal. This is a provisional full refusal of the request for extension of protection to the United States of the international registration, known in the United States as a U.S. application based on Trademark Act Section 66(a). *See* 15 U.S.C. §§1141f(a), 1141h(c).

Introduction

This Office action is supplemental to and supersedes the previous Office action issued on 06/26/2022 in connection with this application. The assigned trademark examining attorney wishes to correct the record by addressing the issue(s) inadvertently omitted from the previous Office action. *See* TMEP §§706, 711.02. The trademark examining attorney apologizes for any inconvenience caused by the delay in raising this issue(s).

In a previous Office action dated 06/26/2022, applicant was required to satisfy the following requirements:

- Requirement: Identification of goods and services clarification
- Requirement: Applicant's email address
- Requirement: U.S.-licensed attorney

Applicant must address the issue(s) raised in this Office action, in addition to the one(s) raised in the previous Office action dated 06/26/2022. The following issue(s) raised in the previous Office action is/are maintained:

- Requirement: Identification of goods and services clarification

Further, the following requirements have been satisfied:

- Requirement: Applicant's email address
- Requirement: U.S.-licensed attorney

See TMEP §713.02.

Summary of issues that applicant must address:

- New issue: Refusal: Section 2(e)(4) – Primarily merely a surname
- Requirement: Identification of goods and services clarification

Refusal: Section 2(e)(4) – Primarily merely a surname

Registration is refused because the applied-for mark is primarily merely a surname. Trademark Act Section 2(e)(4), 15 U.S.C. §1052(e)(4); *see* TMEP §1211.

An applicant's mark is primarily merely a surname if the surname, when viewed in connection with the applicant's recited goods and/or services, "is the primary significance of the mark as a whole to the purchasing public." *Earnhardt v. Kerry Earnhardt, Inc.*, 864 F.3d 1374, 1377, 123 USPQ2d 1411, 1413 (Fed. Cir. 2017) (quoting *In re Hutchinson Tech. Inc.*, 852 F.2d 552, 554, 7 USPQ2d 1490, 1492 (Fed. Cir. 1988)); TMEP §1211.01.

The following five inquiries are often used to determine the public's perception of a term's primary

significance:

- (1) Whether the surname is rare;
- (2) Whether anyone connected with applicant uses the term as a surname;
- (3) Whether the term has any recognized meaning other than as a surname;
- (4) Whether the term has the structure and pronunciation of a surname; and
- (5) Whether the term is sufficiently stylized to remove its primary significance from that of a surname.

In re Colors in Optics, Ltd., 2020 USPQ2d 53784, at *1-2 (TTAB 2020) (citing *In re Benthin Mgmt. GmbH*, 37 USPQ2d 1332, 1333-34 (TTAB 1995) for the *Benthin* inquiries); TMEP §1211.01; *see also In re Etablissements Darty et Fils*, 759 F.2d 15, 16-18, 225 USPQ 652, 653 (Fed. Cir. 1985).

These inquiries are not exclusive, and any of these circumstances – singly or in combination – and any other relevant circumstances may be considered when making this determination. *In re Six Continents Ltd.*, 2022 USPQ2d 135, at *5 (TTAB 2022) (citing *In re tapio GmbH*, 2020 USPQ2d 11387, at *9 (TTAB 2020); *In re Olin Corp.*, 124 USPQ2d 1327, 1330 (TTAB 2017); *Azeka Bldg. Corp. v. Azeka*, 122 USPQ2d 1477, 1480 (TTAB 2017); *In re Integrated Embedded*, 120 USPQ2d 1504, 1506 n.4 (TTAB 2016)); TMEP §1211.01. For example, when the applied-for mark is not stylized, it is unnecessary to consider the fifth inquiry. *In re Yeley*, 85 USPQ2d 1150, 1151 (TTAB 2007); TMEP §1211.01.

See the attached evidence from the LEXISNEXIS® surname database, establishing the surname significance of MERRACHI. This evidence shows the applied-for mark appearing 2 times as a surname in the LEXISNEXIS® surname database, which is a weekly updated directory of cell phone and other phone numbers (such as voice over IP) from various data providers. See the evidence at Attachment 1.

Although MERRACHI appears to be a relatively rare surname, the statute makes no distinction between rare and commonplace surnames and even a rare surname may be unregistrable under Trademark Act Section 2(e)(4) if its primary significance to purchasers is that of a surname. *See In re Etablissements Darty et Fils*, 759 F.2d 15, 16-18, 225 USPQ 652, 653 (Fed. Cir. 1985); *In re Beds & Bars Ltd.*, 122 USPQ2d 1546, 1551 (TTAB 2017); *In re Eximius Coffee, LLC*, 120 USPQ2d 1276, 1281 (TTAB 2016) (citing *In re E. Martinoni Co.*, 189 USPQ 589, 590-91 (TTAB 1975)); TMEP §1211.01(a)(v). There is no minimum amount of evidence needed to establish that a mark is primarily merely a surname. *See In re Etablissements Darty et Fils*, 759 F.2d at 17, 225 USPQ at 653; *In re Beds & Bars Ltd.*, 122 USPQ2d at 1548; TMEP §1211.02(b)(i). Applicant's website, <https://bymerrachi.com/story/>, shows the applicant's use online of the term MERRACHI as a surname. See the evidence from the applicant's website at Attachment 2.

The applicant shows that the applicant is Nada Merrachi. Therefore, applicant uses MERRACHI as a surname.

Evidence that a term has no recognized meaning or significance other than as a surname is relevant to determining whether the term would be perceived as primarily merely a surname. *See In re Six*

Continents Ltd., 2022 USPQ2d 135, at *10-11 (TTAB 2022); *In re tapio GmbH*, 2020 USPQ2d 11387, at *11 (TTAB 2020); *In re Weiss Watch Co.*, 123 USPQ2d 1200, 1203 (TTAB 2017); TMEP §1211.02(b)(vi). The attached evidence from the Macmillan Dictionary and The Columbia Gazetteer of the World shows that MERRACHI does not appear in the dictionary or gazetteer. See the evidence at Attachments 3 and 4. Thus, this term appears to have no recognized meaning or significance other than as a surname.

MERRACHI has the structure and pronunciation of a surname. As evidence of this, attached is Internet evidence from a nationwide telephone directory website, showing surnames that are similar in structure and pronunciation to the surname MERRACHI appearing in the telephone directory. These surnames include: Marachi and Malachi. See the evidence at Attachments 5 and 6. Evidence that a term has the structure and pronunciation of a surname may contribute to a finding that the primary significance of the term is that of a surname. *In re tapio GmbH*, 2020 USPQ2d 11387, at *12 (TTAB 2020) (citing *In re Giger*, 78 USPQ2d 1405, 1409 (TTAB 2006)); *In re Eximius Coffee, LLC*, 120 USPQ2d 1276, 1280 (TTAB 2016); *see*; TMEP §1211.01(a)(vi).

The applied-for mark appears in standard characters. As such, there is no stylization to remove its primary significance from that of a surname.

Therefore, registration must be refused under Trademark Act Section 2(e)(4) because the applied-for mark is primarily merely a surname.

A mark deemed primarily merely a surname may be registered on the Principal Register under Trademark Act Section 2(f) based on a claim of acquired distinctiveness. *See* 15 U.S.C. §1052(f); 37 C.F.R. §2.41(a); TMEP §§1211, 1212. Applicant may respond by asserting a claim of acquired distinctiveness based on one or more of the following:

(1) **Prior Registrations:** Applicant may claim ownership of one or more active prior registrations on the Principal Register of the same mark for goods and/or services that are sufficiently similar to those named in the pending application. 37 C.F.R. §2.41(a)(1); TMEP §§1212, 1212.04. Applicant may do so by submitting the following statement, if accurate: **“The mark has become distinctive of the goods and/or services as evidenced by the ownership of active U.S. Registration No(s). [indicate the registration number] on the Principal Register for the same mark for sufficiently similar goods and/or services.”** TMEP §1212.04(e).

(2) **Five Years’ Use in Commerce:** Applicant may claim use in commerce if the applied-for mark has been in substantially exclusive and continuous use with the identified goods or services for at least the five years before the date on which the claim of distinctiveness is made. 37 C.F.R. §2.41(a)(2); TMEP §1212.05(d). The commerce must be of a type that may be lawfully regulated by the U.S. Congress; use solely in a foreign country or between two foreign countries is not evidence of acquired distinctiveness in the United States. TMEP §§1010, 1212.08; *see In re Rogers*, 53 USPQ2d 1741, 1746-47 (TTAB 1999). Applicant may submit such a claim by providing information regarding the length of use of the mark in commerce and/or dates of use, and including the following written statement, verified with an affidavit or signed declaration under 37 C.F.R. §2.20: **“The mark has become distinctive of the goods and/or services through the applicant’s substantially exclusive and continuous use of the mark in commerce that the U.S. Congress may lawfully regulate for at least the five years immediately before the date of this statement.”** 37 C.F.R. §2.41(a)(2); TMEP §1212.05(d); *see* 37 C.F.R. §2.193(e)(1).

(3) **Other Evidence:** Applicant may submit other evidence of acquired distinctiveness (such as verified statements of long term use, advertising and sales expenditures, examples of advertising, affidavits and declarations of consumers, customer surveys), with the following statement, if accurate: **“The evidence shows that the mark has become distinctive of the goods and/or services.”** See 37 C.F.R. §2.41(a)(3); TMEP §§1212.06–1212.06(e)(vi). When determining whether the evidence shows the mark has acquired distinctiveness, the trademark examining attorney will consider the following six factors: (1) association of the mark with a particular source by actual purchasers (typically measured by customer surveys linking the name to the source); (2) length, degree, and exclusivity of use; (3) amount and manner of advertising; (4) amount of sales and number of customers; (5) intentional copying; and (6) unsolicited media coverage. See *Converse, Inc. v. ITC*, 909 F.3d 1110, 1120, 128 USPQ2d 1538, 1546 (Fed. Cir. 2018) (the *Converse* factors). “[N]o single factor is determinative.” *In re Steelbuilding.com*, 415 F.3d at 1300, 75 USPQ2d at 1424; see TMEP §§1212.06–1212.06(e)(vi). Rather, all factors are weighed together in light of all the circumstances to determine whether the mark has acquired distinctiveness. *In re Steelbuilding.com*, 415 F.3d at 1300, 75 USPQ2d at 1424.

Applicant cannot overcome the refusal by amending the application to the Supplemental Register. A mark in an application under Trademark Act Section 66(a) is not eligible for registration on the Supplemental Register. 37 C.F.R. §§2.47(c), 2.75(c); TMEP §816.01; see 15 U.S.C. §1141h(a)(4).

Requirement: Identification of goods and services clarification

First, the wording “trinkets, namely, charms for key rings, rings, works of art, trophies, key rings, key holders being key chains and key chains made therefrom or coated therewith, not included in other classes” and “coins, namely, collectible, non-monetary, and commemorative” in the identification of goods is indefinite and must be clarified because, as the identification is currently worded, the nature of the goods is unclear. Applicant must clarify the identification by specifying the nature of the goods as is shown in the suggested identification below. See 37 C.F.R. §2.32(a)(6); TMEP §1402.01.

Second, the wording “retailing and wholesaling services, namely, retail store services, online retail store services, wholesale store services featuring clothing, headwear and footwear” and “retailing and wholesaling, namely, retail store services, online retail store services, wholesale store services featuring clothing, headwear and footwear, also via the internet” in the identification of services is indefinite and must be clarified because, as it is currently worded, it is unclear that all of the retail services are intended to feature the listed goods. Applicant must clarify the identification by adding the word “and” as is shown in the suggested identification below. See 37 C.F.R. §2.32(a)(6); TMEP §1402.01.

Suggested identification

Instructions and suggested changes are shown in bold text. Applicant may adopt the following identification, if accurate:

International Class 014: Precious metals and their alloys and trinkets, namely, charms for key rings, rings, works of art, trophies, key rings, key holders being key chains and key chains made **{clarify what the goods are made from, e.g., precious metals and their alloys}** or coated therewith, not included in other classes; jewellery, precious stones; horological and chronometric instruments; clocks; watches; key rings; medals; coins, namely, collectible, non-monetary, and commemorative **{specify the type of goods, e.g., coins}**; jewellery boxes and watch boxes; parts for the aforesaid goods, included in

this class, namely, watch parts and fittings, jewellery chains

International Class 025: No changes needed

International Class 035: Import-export agency services; retailing and wholesaling services, namely, retail store services, online retail store services, **and** wholesale store services featuring clothing, headwear and footwear and business intermediation services in the nature of negotiation of business contracts for others, negotiation of commercial transactions for third parties and business consulting relating to the purchase and sale of clothing, headwear and footwear, also via the internet; retailing and wholesaling, namely, retail store services, online retail store services, **and** wholesale store services featuring clothing, headwear and footwear, also via the internet

Identification advisories

Applicant's goods and/or services may be clarified or limited, but may not be expanded beyond those originally itemized in the application or as acceptably narrowed. *See* 37 C.F.R. §2.71(a); TMEP §§1402.06, 1904.02(c)(iv). Applicant may clarify or limit the identification by inserting qualifying language or deleting items to result in a more specific identification; however, applicant may not substitute different goods and/or services or add goods and/or services not found or encompassed by those in the original application or as acceptably narrowed. *See* TMEP §1402.06(a)-(b). The scope of the goods and/or services sets the outer limit for any changes to the identification and is generally determined by the ordinary meaning of the wording in the identification. TMEP §§1402.06(b), 1402.07(a)-(b). Any acceptable changes to the goods and/or services will further limit scope, and once goods and/or services are deleted, they are not permitted to be reinserted. TMEP §1402.07(e). Additionally, for applications filed under Trademark Act Section 66(a), the scope of the identification for purposes of permissible amendments is limited by the international class assigned by the International Bureau of the World Intellectual Property Organization (International Bureau); and the classification of goods and/or services may not be changed from that assigned by the International Bureau. 37 C.F.R. §2.85(d); TMEP §§1401.03(d), 1904.02(b). Further, in a multiple-class Section 66(a) application, classes may not be added or goods and/or services transferred from one existing class to another. 37 C.F.R. §2.85(d); TMEP §1401.03(d).
