Notification of a Provisional Total Refusal of Protection (not based on an opposition) by the Intellectual Property Office

I have examined your designation under the Trade Marks Act 1994 and carried out a search of the relevant trade mark registers. Your designation does not appear to meet the requirements for Protection for the following reasons.

Absolute grounds for refusal

Section 3(6)

The designation is not acceptable as there is an objection under Section 3(6) of the Act.

The list of goods and services within the designation appears to be very broadly drawn and there appears to be incongruity between the terms claimed. In terms of the breadth of the specification, it is noted, for example, the designation consists of 45 Classes.

In terms of incongruity within the specification, it is noted that the application covers goods and services such as shampoos, babies bottles, xylophones, toys and games, floor coverings, milk products, plant seeds, fishing bait, alcoholic and non-alcoholic beverages, banking services, construction services, operation of lotteries, provision of weather reports, temporary accommodation, medical services, rental of curtains, beauty salons, veterinary services, rental of potted plants, fortune-telling, personal body guarding, pet sitting and providing of grave

spaces or charnel houses.

It is not required that an applicant must already be trading in the goods or services claimed at application stage, or even have a developed intention to be trading in those goods or services. Nevertheless, where an applicant may have no intention of exploring the possibility of business in those areas, this may be considered to be an abuse of the trade mark system.

For the reasons I have outlined above, it would appear that, absent of any explanation or commercial rationale for the breadth of the specification provided with the application, that this application may have been made, at least in part, in bad faith.

Overcome Objection

The objection may be overcome by providing a reasonable commercial rationale for seeking the broad scope of protection or by restricting the goods and services to reflect those for which the applicant has a realistic prospect of providing. If you propose to restrict the specification, we will still require the rationale for the remaining specification.

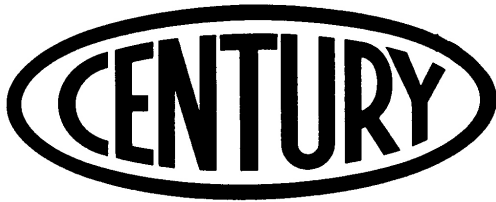
