Relative Dispositions of Greek Trademark law 2239/94 applied on this matter:

Law 2239/94-Article 4 : 1.A trade mark shall not be registered:a)if it is identical with an earlier trade mark and the goods or services for which the trade mark has been registered are identical with the goods or services for which the earlier trade mark is protected.b)if, because of its identity with the earlier trade mark and the similarity of the goods or services or the similarity with the earlier mark and the identity of the goods or services ,there exists a likelihood of confusion on the part of the public, which includes the likelihood of association with he earlier mark.....

As "earlier trade mark" within the meaning of the present Law should be understood:a)trade marks, including community marks, which have been registered before the date of the trade mark , taking account of the priorities claimed in respect of those trade marks.b)earlier applications for registration of trade marks, including community trade marks, subject to their registration.c)trade marks which on the date of application for registration or, where appropriate, on the priority date claimed in respect of the application, are well-known, in the sense of article 6bis of the Paris Convention.

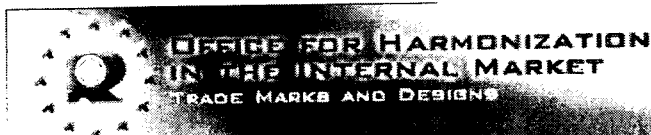
