## Applicant Must Amend The Identification Of Goods

The wording "lighters" in the identification of goods needs clarification because it is too broad and could include goods classified in other international classes. Lighters are generally classified in Class 34, but lighters made of precious metal are classified in Class 14. Applicant may adopt the following identification, if accurate:

"Cigarettes, cigars, cigarillos, smoking tobacco, and lighters not of precious metal, in International Class 34."

TMEP §§1402.01 and 1402.03.

Please note that, while the identification of goods may be amended to clarify or limit the goods, adding to the goods or broadening the scope of the goods is not permitted. 37 C.F.R. §2.71(a); TMEP §1402.06. Therefore, applicant may not amend the identification to include goods that are not within the scope of the goods set forth in the present identification.

Applicant should note that the international classification of goods in applications filed under Trademark Act Section 66(a) cannot be changed from the classification given to the goods and/or services by the International Bureau of the World Intellectual Property Organization in the corresponding international registration. TMEP §§1401.03(d), 1401.04 and 1904.02(b).

## Partial Abandonment Advisory

If applicant should fail to respond to this Office action within the six month time limit, then the following goods and/or services will be deleted from the application: lighters. The application will then proceed forward for the following goods and/or services only: cigarettes, cigars, cigarillos, and smoking tobacco. 37 C.F.R. §2.65(a).
