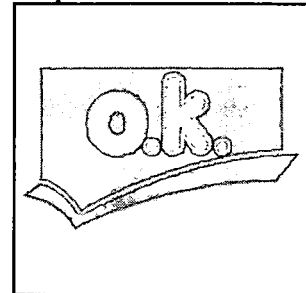

**INFORMATION REGARDING EARLIER RIGHTS**

I have also identified earlier marks which I consider to be confusingly similar to this designation, the holder should be aware of these earlier marks.
