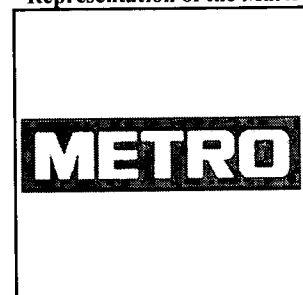

The term **'Wholesale and retail trade services with the following goods.....electrical.....apparatus and instruments'** is unacceptable under Section 1(1) and 3(1)(a) of the Act in that it is too vague and lacks legal clarity. As the specification is unclear in this respect, it will not be possible for the sign to distinguish the services of one undertaking from those of another.

To overcome this refusal, you should list goods by name and restrict them, or provide information to show that the list of services accurately describes the range of services for which the mark is used, or given to be used in the UK.

The term **"Wholesale and retail trade services with the following goods"** is unacceptable under Section 1(1) and 3(1)(a) of the Act in that it is too vague and lacks legal clarity. As the specification is unclear in this respect, it will not be possible for the sign to distinguish the goods/services of one undertaking from those of another.

The objection can be overcome by replacing this term with, **"Wholesale and retail services connected with the sale of...."**

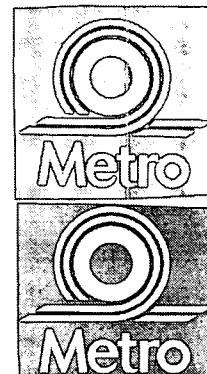

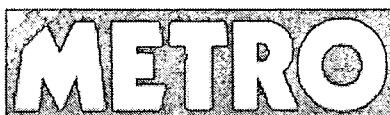

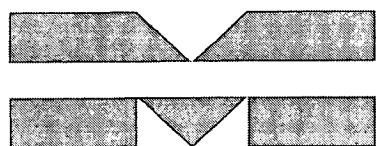
