4. Decision:

The Korean Intellectual Property Tribunal canceled the Decision of Refusal dated 24/04/2008 and returned this case to the examiner.

Accordingly, the examiner has decided to withdraw the Decision of Refusal and the Conformation of Provisional Refusal dated 24/04/2008 respectively. The international registration is to be protected in the Republic of Korea for the designated goods/services listed in item 3.
