cleaning of vehicles" in Class 37, "trainer services and operation of sports halls", "exhibitions for cultural or educational purposes held in bookshops and music stores, (except for sales departments)" and "organization of presentations and round-table discussions" in Class 41, "services relating to engineering and know-how", "information and counseling services (unrelated to business dealings)" and "editorial offices" in Class 42.

7 . The holder of the international registration may request for a review of this refusal. The request for review must be received by the Intellectual Property Office of Singapore no later than four (4) months from the date of this refusal.

The request for review must quote the International Registration number, relevant Singapore trade mark number(s), corresponding class number(s) and Singapore reference number(s) and be accompanied by an address for service in Singapore filed on Form TM 1. The fee payable for Form TM 1 is SGD8.50 for each Singapore trade mark number.

The holder may request for an extension of time to respond to the refusal by filing Form TM 49. There is no fee for the filing of this form. However, one Form TM 49 must be filed for each Singapore trade mark number in respect of which the request is made. The International Registration number, relevant Singapore trade mark number(s) and Singapore reference number(s) must be quoted on each Form TM 49.

If the holder does not file a request for review together with the completed Form(s) TM 1 and the relevant fee or does not file the completed Form(s) TM 49 by 28 January 2011, this refusal will become final.

8 . Please note that a further refusal of protection may result from an opposition, which may be filed after the expiry of 18 months from the date on which the Intellectual Property Office of Singapore was notified of the international registration.

# **PROVISIONS OF SINGAPORE LAW**

## **Trade Marks (International Registration) Rules**

### **Rule 19(2) Specification**

Every application form shall contain, for each class of goods or services to which the application relates -

- (a) the class number as set out in the Third Schedule; and
- (b) a specification of those goods or services which
  - (i) is appropriate to that class;
  - (ii) is described in such a manner as to
    - (A) indicate clearly the nature of those goods or services; and
    - (B) allow those goods or services to be classified in accordance with the Third Schedule; and
  - (iii) complies with any other requirement of the Registrar.

## **TRADE MARKS ACT**

### **(CHAPTER 332)**

#### **Section 2(1) Interpretation**

"earlier trade mark" means-

- (a) a registered trade mark or an international trade mark (Singapore), the application for registration of which was made earlier than the trade mark in question, taking account (where appropriate) of the priorities claimed in respect of the trade marks; or
- (b) a trade mark which, at the date of application for registration of the trade mark in question or (where appropriate) of the priority claimed in respect of the application, was a well known trade mark, and includes a trade mark in respect of which an application for registration has been made and which, if registered, would be an earlier trade mark by virtue of paragraph (a) subject to its being so registered;

#### **Relative grounds for refusal of protection**

8(1) A trade mark shall not be registered if it is identical with an earlier trade mark and the goods or services for which the trade mark is sought to be registered are identical with the goods or services for which the earlier trade mark is protected.

(2) A trade mark shall not be registered if because -

- (a) it is identical with an earlier trade mark and is to be registered for goods or services similar to those for which the earlier trade mark is protected; or

(b) it is similar to an earlier trade mark and is to be registered for goods or services identical with or similar to those for which the earlier trade mark is protected,  
there exists a likelihood of confusion on the part of the public.

Applicant seeks to register the mark "LukOil" while the cited marks consist of "Luk". The subject mark uses the same primary term "Luk" as the already registered marks. Applicant has merely added a word "Oil" to the already registered mark. The mere addition of a word to a registered mark generally does not obviate the similarity between the marks nor does it overcome a likelihood of confusion. As such, the public might be mistaken that the subject mark and cited marks are variant marks under the same owner. Please file consent letter from the cited owner to overcome the citations. For cited mark T0016450D in Class 04, the objection is directed at the goods "fuel (including engine fuels) and combustible briquettes; gas and alcohols, not included in other classes; petroleum (raw or refined)" in the subject application. For cited mark T0407691Z in Class 16, the objection is directed at the goods "Printed matter, including books, pamphlets, calendars, magazines (periodicals), newspapers, guidebooks; geographical maps; atlases; paintings, engravings; artwork made of papier-mache not included in other classes", "flags and pennants of paper", "paper and paper goods not included in other classes, paintbrushes; artists' materials; training or teaching material (except apparatus); stationery items; office requisites (except furniture); jackets for documents; covers (stationery) (except those which are made of leather and imitation leather); photographs; decalcomanias; stickers (stationery items)" in the subject application. For cited mark T0016456C in Class 37, the objection is directed at the services "Vehicle service stations; cleaning of vehicles" in the subject application. For cited mark T0016458Z in Class 41, the objection is directed at the services "trainer services" in the subject application.

3 The specification of goods/services is objectionable under rule 19(2)(b)(ii)(A) of the Trade Marks Rules as it does not indicate clearly the nature of the following items:

(a) Class 07

- (i) "equipment used for gas separation, including apparatus equipped with membranes". Please consider to amend it to "machine equipment used for gas separation, including machines apparatus equipped with membranes" to better conform with the Nice Classification,

(b) Class 35

- (i) "sale by auction". Please consider to amend it to "auctioneering" to better conform with the Nice Classification,

(c) Class 41

- (i) "trainer services and operation of sports halls". Please consider to amend it to "provision of training services; provision of sports halls" to better conform with the Nice Classification,
- (ii) "exhibitions for cultural or educational purposes held in bookshops and music stores, (except for sales departments)". Please consider to amend it to "organization of exhibitions for cultural or educational purposes held in bookshops and music stores, (except for sales departments)" to better conform with the Nice Classification,
- (iii) "organization of presentations and round-table discussions". Please consider to amend it to "organization of live presentations and discussions for entertainment purposes" to better conform with the Nice Classification,

(d) Class 42

- (i) "services relating to engineering and know-how". Please consider to amend it to "engineering services and provision of engineering information",
- (ii) "information and counseling services (unrelated to business dealings)". Please clarify the subject matter of the information services to assist in the classification process,
- (iii) "editorial offices". Please clarify the subject matter of the information services to assist in the classification process.

4 This refusal applies to the items "fuel (including engine fuels) and combustible briquettes; gas and alcohols, not included in other classes; petroleum (raw or refined)" in Class 04, "equipment used for gas separation, including apparatus equipped with membranes" in Class 07, "printed matter, including books, pamphlets, calendars, magazines (periodicals), newspapers, guidebooks; geographical maps; atlases; paintings, engravings; artwork made of papier-mache not included in other classes", "flags and pennants of paper", "paper and paper goods not included in other classes, paintbrushes; artists' materials; training or teaching material (except apparatus); stationery items; office requisites (except furniture); jackets for documents; covers (stationery) (except those which are made of leather and imitation leather); photographs; decalcomanias; stickers (stationery items)" in Class 16, "sale by auction" in Class 35, "vehicle service stations; cleaning of vehicles" in Class 37, "trainer services and operation of sports halls", "exhibitions for cultural or educational purposes held

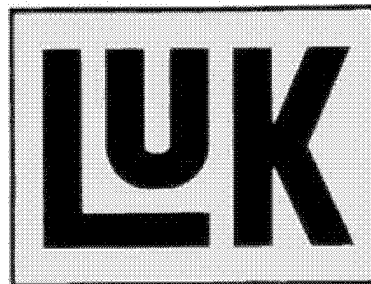

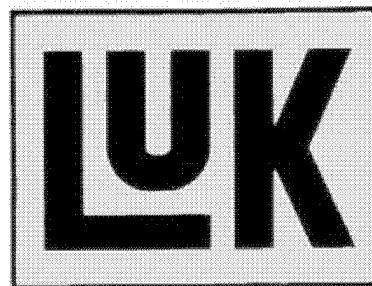
