4. Decision:

All procedures before KIPO relating to the protection of the mark have been completed. The assigned examiner has decided to withdraw the provisional refusal dated 22/04/2011, 21/09/2011. Therefore the international registration is to be protected in the Republic of Korea for the designated goods/services listed in item 3.
