2 Registration of the mark is refused under Rule 19(2)(b)(ii)(A) of the Trade Marks Rules as the descriptions of the goods and services in Classes 1, 2, 3, 5, 6, 7, 9, 10, 11, 14, 16, 17, 19, 35, 36, 37, 38, 39, 40, 41, 42, 43 and 44 are vague. The refusal is pointed at:

(a) Class 1

- (i) "synthetic resins" - for clarity, please consider amending to "synthetic resins (unprocessed)";
- (ii) "phosphorescent substances" - for clarity, please consider amending to "phosphorescent substances (other than paints)";
- (iii) "fused quartz in various shapes, such as disks, ingots, shanks and tubes for general use in applied arts" - the description of this item is vague. Please elaborate on the nature of the good to aid in our understanding of it;
- (iv) "thermoplastic and thermosetting adhesives" - for clarity, please consider amending to "thermoplastic and thermosetting adhesives for industrial purposes", if intended;
- (v) "luminescence reagents" - for clarity, please consider amending to "luminescence reagents for industrial use", if intended;
- (vi) "chromatography media" - for clarity, please consider amending to "media for use in chromatography (not medical)", if intended;

- (vii) "tests for high data rate analysis for producing medicines" - the description of this item is not clear. Please clarify;
- (viii) "reagents for high-resolution laser microscopy, fluoroscopic microscopy and confocal microscopy" - for clarity, please confirm that we may amend this item to read as "reagents for high-resolution laser microscopy, fluoroscopic microscopy and confocal microscopy (other than for medical or veterinary purposes)", if appropriate;
- (ix) "radioactive sources and norms for radiographic technology" - for clarity, please consider amending to "radioactive sources and norms for radiographic technology (scientific)", if intended;
- (x) "radioactive sources for non-destructive testing, purification and sterilization technology" - for clarity, please consider amending to "radioactive sources for non-destructive testing, purification and sterilization technology (scientific)", if intended;
- (xi) "bags with chemically treated granular materials for absorbing water to be placed in fuel tanks" - the description of this item is vague. Please clarify or elaborate on the nature of the good to aid in our understanding of it;
- (xii) "chemicals, catalysts, plastic semi-processed goods used as materials, filters for removing acid gases, untreated plastics, crystal whiskers and diamond gray" - the description of this item is vague as "plastics semi-processed goods" appears to be proper to Class 17. Please consider rewording this item to conform to Class 1;
- (xiii) "polymeric membrane materials for liquid separation" - for clarity, please consider amending to "polymeric membrane materials for liquid separation (chemicals)", if intended;

(b) Class 2

- (i) "corrosion inhibitors in the form of a coating for use in the metal-finishing industry, namely an aqueous acid product for final flushing" - the description of this item is vague. Please clarify on "aqueous acid product for final flushing";
- (ii) "covering materials, etching liquids" - the description of this item is vague. Please specify the nature of the "covering materials" and "etching liquids" appears to be proper to Class 1. Please clarify;
- (iii) "toner cartridges for printers" - for clarity, please consider amending to "toner cartridges (filled) for printers", if intended;

- (iv) "toner, toner for copiers, toner for facsimile machines" - for clarity, please consider amending to "toners in the nature of dyestuffs, toner cartridges (filled) for copiers, toner cartridges (filled) facsimile machines", if appropriate;
- (c) Class 3
- (i) "cleaning preparations containing chemicals and chemical compounds for cleaning steel, aluminum, mixed and galvanized metal surfaces for general industrial use for manufacturing goods of metal" - the description of this item appears to be analogous to "chemical products for use in industrial cleaning processes" in Class 1. For clarity, please consider rewording to "chemical cleaning preparations for cleaning steel, galvanized and mixed metal surfaces", if appropriate;
 - (ii) "cleaning agents containing chemicals and chemical compounds for industrial use for removing contaminants in industrial process systems" - the description of this item appears to be analogous to "chemical cleaning agents for use in industrial processes" in Class 1. Please clarify;
- (d) Class 5
- (i) "pre-filled bottles containing reagents for medical diagnosis"- for clarity, please confirm that we may amend this item to read as "medical diagnostic reagents contained in pre-filled bottles";
 - (ii) "pre-filled cartridges containing chemical solutions for medical use" - for clarity, please confirm that we may amend this item to read as "chemical solutions for medical solutions contained in pre-filled cartridges";
 - (iii) "pre-filled cylinders containing gases and gas mixtures for medical use" - for clarity, please confirm that we may amend this item to read as "gases and gas mixtures for medical purposes contained in pre-filled cylinders";
 - (iv) "implantable radiotherapy devices consisting of radio-isotope brachytherapy sources in capsules" - the description of this item is vague and appears to be proper to Class 10. Please clarify;
 - (v) "radiotherapy administration system consisting of radioactive pellets and of a bioabsorbable carrier set" - the description of this item is vague. Please clarify or elaborate on the nature of the good to aid in our understanding of it;

(e) Class 6

- (i) "chains for keys" - for clarity, please consider amending to "key chains of common metal", if intended;
- (ii) "trolley wires for wiring, doors of metal, barriers of metal, electric garage doors, acid-resistant high-polymer coatings, sheet steel, steel panels for office floors, welding wires" - the description of this item is vague as it is unclear if the items are claimed separately or together as an entity. Please clarify;

(f) Class 7

- (i) "turbines" - the description of this item is vague and may encompass items from other classes. For clarity, please consider amending "turbines for power generation", if intended;
- (ii) "solar energy electricity generators" - the description of this item appears to be analogous to "solar energy collectors for electricity generation" in Class 9. Please clarify;
- (iii) "machines and systems of machines, including parts and accessories for electricity production, transformation and conversion" - the description of this item is vague as "parts and accessories for electricity production, transformation and conversion" does not appear to be proper to Class 7. Please clarify;
- (iv) "dynamos, electric motors of all kinds, steam and gas turbines and their parts, electrical generators and their parts, aircraft engines, compressors" - the description of this item is vague and may encompass items from other classes. For clarity, please consider amending to "dynamos, electric motors (other than for land vehicles), gas and steam turbines and components thereof (other than for land vehicles), electrical generators and their parts, aircraft engines, compressors (machines)", if appropriate;
- (v) "liquid control devices, namely valves, regulators, actuators, ejectors, liquid separation cartridges and their parts, including semi-permeable diaphragms" - for clarity, please consider amending to "liquid control devices, namely valves, regulators, actuators, ejectors, liquid separation cartridges and their parts, including semi-permeable diaphragms, all the aforesaid being parts of machines", if appropriate;
- (vi) "axial-flow and radial-flow compressors" - for clarity, please consider amending to "axial-flow and radial-flow compressors

(machines)", if intended;

- (vii) "screw and sliding-vane compressors" - for clarity, please consider amending to "screw and sliding-vane compressors (machines)", if intended;
- (viii) "welding machines, industrial robots, machines for insertion of electronic components, dry etching machines, electric micro-discharge machines, systems for production of optical discs, precision connection equipment, treatment machines for printed wiring panels, welding rods, machines for assembling parts, brazing machines, machines for fixing screws, electrical tools" - the description of "systems for production of optical discs, precision connection equipment" is vague. Please clarify;
- (ix) "garden tools, electric lawnmowers, garden vaporizers for disinfectants and insecticides" - for clarity, please consider amending to "electric gardening tools, electric lawnmowers, garden vaporizers (machines) for disinfectants and insecticides", if intended;
- (x) "electric window washers" - for clarity, please consider amending to "electric window washers (machines)", if intended;
- (xi) "mixers, centrifuges, hand-held mixers, food processors" - for clarity, please consider amending to "mixers, centrifuges, hand-held mixers, food processors, all the aforesaid being machines", if intended;

(g) Class 9

- (i) "fuel pumps for service stations for aircraft engine refuelling" - for clarity, please consider amending to "fuel dispensing pumps for service stations", if appropriate;
- (ii) "fuel distribution equipment, namely calibrated fuel pumps, electric fuel-level gauges, control valves for regulating gas flow and fuel lines" - for clarity, please consider amending to "fuel distribution equipment, namely calibrated fuel pumps, electrical fuel level gauges, **ELECTRIC** control valves for regulating gas flow rate and fuel lines", if intended;
- (iii) "automated systems for service-station management comprising operating software, calibrated fuel pumps, flow control panels, fuel lines and pump nozzles for refueling of land vehicles, marine vehicles and aircraft" - the description of this item is vague. Please clarify;

- (iv) "electrical products, electricity production and distribution products and voltage surge protection products, namely lightning conductors, armored rods" - please clarify what are "armored rods";
- (v) "DELS" - the description of this item is vague. Please provide its full terminology;
- (vi) "chromatography columns and pumps" - for clarity, please consider amending to "chromatography columns and pumps for scientific or laboratory use", if intended;
- (vii) "oligonucleotide-producing apparatus" - the description of this item appears to be analogous to "machines for manufacturing polymeric materials" in Class 7 as "oligonucleotides" seems to be a kind of polymer. Please clarify;
- (viii) "vials and micro-vials" - for clarity, please consider amending to "vials and micro-vials for laboratory use", if intended;
- (ix) "microtiter plates" - for clarity, please consider amending to "microplates (reagent testing apparatus), other than for medical use", if appropriate;
- (x) "software and manuals therefor sold in the form of sets for plant management" - for clarity, please consider amending to "software and manuals in electronic format sold as a unit for plant management", if intended;
- (xi) "applications for manufacture and control, namely for statistical process control, data collection, direct digital control" - for clarity, please consider amending to "application software for manufacture and control, namely for statistical process control, data collection, direct digital control", if intended;
- (xii) "anti-theft and burglar alarm systems" - for clarity, please consider amending to "anti-theft and burglar alarm systems (other than for vehicles)", if intended;
- (xiii) "apparatus for shooting and filming" - for clarity, please consider amending to "film production apparatus", if intended;
- (xiv) "key holders and their readers and encoders" - the description of this item is vague. Please clarify;
- (xv) "and security cases in the form of boxes for keys" - the description of this item is vague. Please clarify;

- (xvi) "timers or sensitive apparatus for detecting changes in conditions for launching and monitoring regeneration or washing cycles for waster treatment equipment"- please clarify what is "sensitive apparatus";
 - (xvii) "control valves for water treating and filtering equipment" - for clarity, please consider amending to "electric control valves for water treating and filtering equipment", if appropriate;
 - (xviii) "electronic controls for water treatment and processes, namely apparatus for treatment of industrial and commercial water supply systems, boiler water systems, water cooling systems, cooling water systems and closed water-supply systems, systems for paper and pulp treatment, fuel treatment systems and metal treatment systems for analyzing system chemistry, determining the right treatment program, applying the desired treatment and monitoring treatment efficacy" - the description of this item is not clear. Please clarify;
 - (xix) "carbon, carbon electrodes for dry batteries, carbon electrodes for welding" - the description of this item is vague and "carbon" appears to be proper to Class 1. Please consider rewording this item to conform to Class 9;
- (h) Class 9 (continued)
- (i) "wiring apparatus, connectors (electric), electric cables, electric ducts, floor ducts specially designed for housing electric cables, ballast (for discharge lamps), wiring systems under carpets, code lighting switches, circuit breakers, magnetic starter switches and contactors, circuit protectors, switching devices, electric connecting boxes, device switches, output jacks, plugs (electric), insulating materials, electric timers, other wiring devices" - please delete "insulating materials" as it is proper to Class 17. Please specify the goods claimed for "other wiring devices" as the use of "other" renders the item vague;
 - (ii) "acoustic machines and apparatus, radios, tape recorders/players, radio cassette recorders, portable tape players, compact disc recorders/players, minidisc recorders/players, minidisc consoles, DVD audio recorders/players, secured digital recorders/players, secured digital cards, loudspeakers, tuners, amplifiers, stereo systems, disc readers, graphic equalizers, alarm clocks, integrated circuit recorders, digital audio processing devices, earphones, headphones, microphones, cassette recorders/players, software for compact discs (prerecorded), electric megaphones, language laboratories, audio systems for cars, public address systems, mixing

consoles, cleaning products for audio equipment, audio cables, video cables, other audio machines" - for clarity, please consider amending to "ACOUSTIC DEVICES AND APPARATUS, radios, tape recorders/players, radio cassette recorders, portable tape players, compact disc recorders/players, minidisc recorders/players, minidisc consoles, DVD audio recorders/players, DIGITAL AUDIO PLAYERS, MEMORY CARDS, loudspeakers, ELECTRONIC TUNERS, amplifiers, stereo systems, disc readers, graphic equalizers, alarm clocks, integrated circuit recorders, digital audio processing devices, earphones, headphones, microphones, cassette recorders/players, software for compact discs (prerecorded), electric megaphones, LANGUAGE LIBRARIES, audio systems for cars, public address systems, mixing consoles, CLEANING APPARATUS ESPECIALLY ADAPTED FOR USE WITH RECORDING AND PLAYBACK EQUIPMENT AND RECORDED MATERIAL", if appropriate;

- (iii) "automatic control machines and instruments, electric distribution boards, road signal control apparatus, bus placement systems, ultrasound vehicle detectors, information and telecommunication networks for road traffic management, light dimmers, light switches, inverters, programmable control systems, transformers, cabinets, domestic electricity production systems, power capacitors" - please clarify on what are "ultrasound vehicle detectors" and "cabinets";
- (iv) "external storage devices, video cassettes, cleaning heads, D-VHS (video systems for household use), other computer peripherals" - the use of "other" renders the description of this item vague. For clarity, please consider amending to "external storage devices, video cassettes, CASSETTE HEAD CLEANERS FOR VIDEO TAPES, D-VHS (video systems for the home), COMPUTER PERIPHERAL DEVICES", if appropriate;
- (v) "weighing and measuring apparatus and instruments, thermoluminescent dosimetry systems, portable x-ray dosimeters, electronic meters, ammeters, electricity consumption meters, grip measuring devices, electric apparatus for measuring leakance, electric insulation meters, thermometers, measuring system processors, electric multi-circuit sector voltage monitors, micro-precision measuring devices, body fat monitors, pacers, audio/video analyzers, oscilloscopes, modulators, voltmeters, distortion meters, other measuring apparatus" - the description of this item is not clear and the use of "other" renders the description vague. Please clarify what are "pacers". For clarity, please consider amending to "weighing and measuring apparatus and instruments, thermoluminescent dosimetry systems, portable x-ray dosimeters, electronic meters, ammeters, electricity consumption meters, grip measuring devices, electric apparatus for

measuring leakance, electric insulation meters, thermometers (NOT FOR MEDICAL PURPOSES), measuring system processors, electric multi-circuit sector voltage monitors, micro-precision measuring devices, body fat monitors (NOT FOR MEDICAL PURPOSES), pacers, audio/video analyzers, oscilloscopes, modulators, voltmeters, distortion meters, MEASURING APPARATUS", if appropriate;

- (vi) "sensors, light-sensitive sensors, thermometric sensors, position sensors, angular velocity sensors, rotation sensors, angle sensors, dew point sensors, other sensors" - please note that the use of "other" renders the description vague. For clarity, please consider amending to "SENSORS (MEASUREMENT APPARATUS), OTHER THAN FOR MEDICAL USE, light-sensitive sensors, thermometric sensors, position sensors, angular velocity sensors, rotation sensors, angle sensors, dew point sensors", if appropriate;
- (vii) "electric components, LEDs, liquid crystals, liquid crystal display modules, magnetrons, diodes, transistors, thermostats, integrated circuits, semi-conductor storage devices, micro-computers with a single chip, cartridges for microphones with electric capacitor, gray-scale image processors, thermal print heads, magnetic heads, permanent magnets, connectors, relays, display components, semi-conductor lasers, charge coupling devices, image detectors, film capacitors, over-oxygenation membrane units, electric tuner units, high-frequency units, coin validation units, note validation units, magnetic card reading/writing devices, voltage-controlled oscillators, phase-locking circuit synthesizing modules, wireless communication module units, optical transmission components, printed wiring boards, loudspeaker components, electricity supplies, AC adaptors, focusing magnets, inductors (coils), capacitors for electric apparatus, electric signal filters, transformers, deflection coils, thermistors, varistors, piezoelectric ceramic components, acoustic-optical components, resistances, potentiometers, encoders, printing units, hybrid integrated circuits, switching components, heat-welding wiring boards, transparent button boards, electroluminescent components, remote control units, magnetic resistance elements, thermal disconnects, other electric utensils for household use, electric flat irons, electric hair curlers, electric hair straightening or curling irons" - the description of this item is not clear. Please clarify on what are "over-oxygenation membrane units", "coin validation units, note validation units" and "thermal disconnects". Please consider amending "electricity supplies" to "apparatus for electricity supply", if intended. Please delete "other electric utensils for household use" as it is vague;

- (viii) "machines for banking institutions" - the description of this item is vague. For clarity, please consider amending to "automated banking machines", if intended;
- (ix) "electric and electronic products, namely calculating machines, pocket planners, alarms and torches" - the description of this item is vague and some of the items do not appear to be proper to Class 9. Please consider rewording it to conform to Class 9;
- (x) "machines and machine systems, including parts and accessories for transmission, distribution and control of electricity" - the description of this item is vague and appears to be proper to Class 7. Please consider rewording it to conform to Class 9;
- (xi) "induction devices, electrical displacement devices, electricity control and regulation devices, electricity measuring instruments, electrical protection devices, switchboards, switchboard apparatus, wiring devices and supplies" - for clarity, please consider amending to "INDUCTIVE ELECTRICAL APPARATUS, electrical displacement devices, electricity control and regulation devices, electricity measuring instruments, electrical protection devices, switchboards, switchboard apparatus, wiring devices and supplies", if appropriate
- (xii) "liquid control devices, namely, flowmeters, manostats, sequential timers, electric controls and switches" - please clarify what are "manostats";
- (xiii) "electric devices for killing insects, audio amplifiers for keyboards, external memories for musical instruments" - for clarity, please consider amending to "electric devices for killing insects, audio amplifiers for keyboards, EXTERNAL MEMORY DEVICES for musical instruments", if intended;
- (xiv) "systems for managing data and preserving archives in the field of anesthesia" - the description of this item is not clear. Please clarify;

(i) Class 10

- (i) "test kits for clinical medical use comprising test tubes, test plates and indicator diagrams for evaluating test results" - for clarity, please consider rewording to "testing apparatus comprising test tubes, test plates and indicator diagrams for evaluating test results in kit form (medical)", if appropriate;

- (ii) "patient monitoring systems, namely gas monitors" - for clarity, please consider amending to "patient monitoring systems, namely, gas monitors (medical)", if intended;
- (iii) "pulse oximeters, multi-parameter monitors, ECG monitors, invasive and non-invasive blood pressure monitors, neuromuscular transmission monitors, metabolic monitors and spirometers for diagnostic, intensive care and anesthesia applications" - for clarity, please consider amending to "pulse oximeters, multi-parameter monitors, ECG monitors, invasive and non-invasive blood pressure monitors, neuromuscular transmission monitors, metabolic monitors and spirometers for diagnostic, intensive care and anesthesia applications, ALL THE AFORESAID BEING MEDICAL APPARATUS";
- (iv) "anesthesia and intensive care accessories for a single patient, namely gas sampling lines, airway adapters, respiratory circuits, spirometry tubes and sensors, tubes, water separators, pulse oximetry sensors, non-invasive sphygmomanometers, rinsing sets, anesthesia masks, carbon dioxide absorbers, temperature-sensing probes and nebulizers" - for clarity, please consider amending to "anesthesia and intensive care accessories for a single patient, namely gas sampling lines, airway adapters, respiratory circuits, spirometry tubes and sensors, tubes, water separators, pulse oximetry sensors, non-invasive sphygmomanometers, rinsing sets, anesthesia masks, carbon dioxide absorbers, temperature-sensing probes and nebulizers, ALL THE AFORESAID BEING MEDICAL APPARATUS";
- (v) "central nervous system monitors" - for clarity, please consider amending to "central nervous system monitors (medical apparatus)", if intended;
- (vi) "gastric tonometers" - for clarity, please consider amending to "gastric tonometers (medical apparatus)", if intended;
- (vii) "gradient coils, namely magnetic gradient coils for magnetic resonance imaging" - the description of this item is vague. Please clarify what are "gradient coils";
- (viii) "medical diagnosis apparatus for displaying diagnostic images, namely spot film apparatus, image intensifiers, fluoroscopes, mobile x-ray devices, x-ray film viewers, CAT scans, nuclear resonance apparatus, ultrasound scanners, magnetic resonance apparatus, positron emission tomography apparatus (PET scans) and their parts and accessories, including tables and pads" - for clarity, please consider amending to "medical diagnosis apparatus for displaying
