Class 3- Windscreen cleaning liquids

Class 4- Dust-absorbing, wetting and binding compositions; fuel (including engine fuels) and combustible briquettes; gas and alcohols not included in other classes; petroleum (raw or refined).

Class 16- Printed matter, including books, pamphlets, calendars, magazines (periodicals), newspapers, guidebooks; labels, not of textile; flags and pennants of paper; paper or plastic sachets and bags (wrappers, sleeves) used for packaging; plastic film for wrapping; paper and paper goods not included in other classes; training or teaching material (except apparatus); stationery items; office requisites (except furniture); folders for documents; covers (stationery) (except for those which are made of leather and imitation leather); photographs; decalcomanias; stickers (stationery items).

Class 35- Advertizing; market studies; business and statistical information; auctioning; import-export agencies; document reproduction; commercial or industrial management assistance; projects (business management assistance); computerized file management; organization of fairs and exhibitions for commercial or promotional purposes; business and statistical information on available jobs; business research; efficiency experts; sales promotion (on behalf of third parties); services relating to computer-aided sorting and processing of scientific research findings.

Class 36- Insurance underwriting; capital investment; credit bureaux; financial information; leasing of real estate; real estate management; mutual funds; charitable fund raising; banking; financial affairs, stock exchange quotations; brokerage; safe deposit services; factoring.

Class 37- Vehicle service stations; vehicle repair, vehicle maintenance, vehicle cleaning; road paving and road surfacing repair; installation, maintenance and repair of machinery, refrigerating apparatus, electrotechnical and electronic apparatus; building construction, repair and cleaning; communication system installation for buildings; rental of construction equipment; explosion work; quarrying services; mining extraction, including gas and petroleum extraction; drilling of wells; trench digging; pipeline construction and maintenance.

VI. Once a trade mark is accepted, it must be advertised in our official Trade marks Journal.

Within the opposition period (3 months), other people may oppose protection of your trade mark. If no one has opposed the protection of your trade mark, by the end of the opposition period, your trade mark will be granted and registered in Israel.
