VI. Corresponding essential provisions of the applicable law:

Applied articles of Greek trademark law in case of notice of opposition (Article 140 of law 4072/2012):

- 1. The examiner's decision accepting the registration of application may be opposed within a threemonth period as from its publication on the website of the General Secretariat of Commerce in accordance with par. 1 and 3 of Article 139, for a registration being contrary to one or more grounds of Article 123 and par. 1 and 3 of Article 124 of this law.
- 2. If there are absolute grounds as per Article 123, the opposition can be filed by anyone who has a legitimate interest. Chambers as well as consumers associations have a legitimate interest as per Law 2251/1994.
- 3.If there are absolute grounds as per Article 124 paragraphs 1 and 3, the opposition shall be filed by the proprietors of carlier trademarks or rights, as well as by licensces authorized by the proprietors of those trademarks, according to the terms and conditions of Article 132.
- 4. The opposition shall be filed by a document submitted to the Trademark Office and the Administrative Trademark Committee shall be responsible for taking decisions in relation to it. It shall not be treated as duly entered until the opposition fee has been paid.
