SECTION 2(d) REFUSAL – LIKELIHOOD OF CONFUSION

Registration of the applied-for mark is refused because of a likelihood of confusion with the marks in U.S. Registration Nos. **1935618** and **4004329**. Trademark Act Section 2(d), 15 U.S.C. §1052(d); see TMEP §§1207.01 *et seq.* See the enclosed registrations.

Trademark Act Section 2(d) bars registration of an applied-for mark that so resembles a registered mark that it is likely that a potential consumer would be confused, mistaken, or deceived as to the source of the goods and/or services of the applicant and registrant. See 15 U.S.C. §1052(d). In the seminal decision *In re E. I. du Pont de Nemours & Co.*, 476 F.2d 1357, 177 USPQ 563 (C.C.P.A. 1973), the court listed the principal factors to be considered when determining whether there is a likelihood of confusion under Section 2(d). See TMEP §1207.01. However, not all the factors are necessarily relevant or of equal weight, and any one of the factors may control in a given case, depending upon the evidence of record. *Citigroup Inc. v. Capital City Bank Grp., Inc.*, 637 F.3d 1344, 1355, 98 USPQ2d 1253, 1260 (Fed. Cir. 2011); *In re Majestic Distilling Co.*, 315 F.3d 1311, 1315, 65 USPQ2d 1201, 1204 (Fed. Cir. 2003); see *In re E. I. du Pont de Nemours & Co.*, 476 F.2d at 1361-62,

177 USPQ at 567.

In this case, the following factors are the most relevant: similarity of the marks, similarity and nature of the goods and/or services, and similarity of the trade channels of the goods and/or services. *See In re Vittera Inc.*, 671 F.3d 1358, 1361-62, 101 USPQ2d 1905, 1908 (Fed. Cir. 2012); *In re Dakin's Miniatures Inc.*, 59 USPQ2d 1593, 1595-96 (TTAB 1999); TMEP §§1207.01 *et seq.*

Comparison of the Marks

Applicant's mark is JÖRG HEINZ in stylized form, owned by Jörg Heinz GmbH & Co.

Registration Nos. 1935618 and 4004329

The registered marks are HEINZ in typed and standard character form, owned by H. J. Heinz Company and ProMark Brands, Inc, respectively.

In this case, the marks are confusingly similar because they feature the term HEINZ. Marks may be confusingly similar in appearance where there are similar terms or phrases or similar parts of terms or phrases appearing in both applicant's and registrant's mark. *See Crocker Nat'l Bank v. Canadian Imperial Bank of Commerce*, 228 USPQ 689 (TTAB 1986), *aff'd sub nom. Canadian Imperial Bank of Commerce v. Wells Fargo Bank, Nat'l Ass'n*, 811 F.2d 1490, 1 USPQ2d 1813 (Fed. Cir. 1987) (COMMERCASH and COMMUNICASH); *In re Phillips-Van Heusen Corp.*, 228 USPQ 949 (TTAB 1986) (21 CLUB and "21" CLUB (stylized)); *In re Corning Glass Works*, 229 USPQ 65 (TTAB 1985) (CONFIRM and CONFIRMCELLS); *In re Collegian Sportswear Inc.*, 224 USPQ 174 (TTAB 1984) (COLLEGIAN OF CALIFORNIA and COLLEGIENNE); *In re Pellerin Milnor Corp.*, 221 USPQ 558 (TTAB 1983) (MILTRON and MILLTRONICS); *In re BASF A.G.*, 189 USPQ 424 (TTAB 1975) (LUTEXAL and LUTEX); TMEP §1207.01(b)(ii)-(iii).

Furthermore, it is fairly common for companies making and/or marketing clothing and jewelry to market these items under a designer name. In doing so, they will often use the designer's (whether real, deceased or fictional) surname alone for certain lines and use the full name on other lines. As evidence of this common practice, please see the attached prior third party registrations and evidence of actual use in commerce. Some of those attached are LIZ CLAIBORNE & CLAIBORNE; SALVATORE FERRAGAMO & FERRAGAMO; HUGO BOSS & BOSS and RALPH LAUREN & LAUREN. Because consumers are familiar with this practice, they are likely to believe that JÖRG HEINZ used on various jewelry items emanate from the same source as HEINZ used on jewelry and clothing. *See In re Chatham International Incorporated*, 380 F.3d 1340, 71 USPQ2d 1944 (Fed. Cir. 2004), (comparing the mark JOSE GASPARD GOLD for tequila against the registered mark GASPARD'S ALE for beer and ale, the Court held that "[w]ith respect to 'Jose,' the Board correctly observed that the term simply reinforces the impression that 'Gaspar' is an individual's name); *See also Nina Ricci S.A.R.L. v. E.T.F. Enterprises Inc.*, 889 F.2d 1070, 12 USPQ2d 1901 (Fed. Cir.1989) (holding that VITTORIO RICCI and NINA RICCI are confusingly similar and noting that the Trademark Trial and Appeal Board has previously recognized the practice in the fashion industry of referring to surnames alone"). Thus, in the instant case, the addition of the given name JÖRG in the registrant's mark does not alter the commercial impression of the surname HEINZ in the applicant's mark.

Therefore, the marks are confusingly similar.

Comparison of the Goods

Applicant's goods are "real and fashion jewelry; clasps for jewelry" in International Class 14

Registration No. 1935618

Registrant's goods include "caps" in International Class 25.

Applicant's and registrant's goods are related for the following reasons.

Thus, upon encountering applicant's and registrants' marks used on the identified goods, consumers are likely to be confused and mistakenly believe that the respective goods emanate from a common source. Accordingly, registration of the applied-for mark is refused because of a likelihood of confusion with the marks in U.S. Registration Nos. 1935618 and 4004329. Trademark Act Section 2(d), 15 U.S.C. §1052(d); *see* TMEP §1207.01 *et seq.*

Although applicant's mark has been refused registration, applicant may respond to the refusal by submitting evidence and arguments in support of registration.

ADVISORY: OWNERSHIP OF CITED REGISTRATIONS

If the marks in the cited registrations have been assigned to applicant, applicant may provide evidence of ownership of the marks by satisfying one of the following:

- (1) Record the assignment with the USPTO's Assignment Recordation Branch (ownership transfer documents such as assignments can be filed online at <http://etas.uspto.gov>) and promptly notify the trademark examining attorney that the assignment has been duly recorded.
- (2) Submit copies of documents evidencing the chain of title.
- (3) Submit the following statement, verified with an affidavit or signed declaration under 37 C.F.R. §2.20: **"Applicant is the owner of U.S. Registration Nos. 1935618 and 4004329."**

TMEP §812.01; *see* 15 U.S.C. §1060; 37 C.F.R. §§2.193(e)(1), 3.25, 3.73(a)-(b); TMEP §502.02(a).

Recording a document with the Assignment Recordation Branch does not constitute a response to an Office action. TMEP §503.01(d).

Applicant must respond to the requirements set forth below.

INQUIRY: NAME OF AN INDIVIDUAL

The applied-for mark contains the name "JÖRG HEINZ" and appears to identify a particular living individual; however, the application does not include this named party's written consent to registration of the name as a trademark. Written consent is required for registration of a mark containing a name, including a pseudonym, stage name or nickname, or signature, if the name or signature identifies a particular living individual. Trademark Act Section 2(c), 15 U.S.C. §1052(c); TMEP §§813, 1206.04(a). Therefore, applicant must clarify whether this name identifies a particular living individual and, if so, provide a written consent from this individual, as explained further below. 37 C.F.R. §2.61(b); TMEP §§813, 1206.04(a).

If the name or signature in the mark does not identify a particular living individual, then applicant must submit a statement that the name "JÖRG HEINZ" does not identify a living individual. TMEP §§813.01(b), 1206.05; *see* 37 C.F.R. §2.61(b).

If the name or signature in the mark does identify a particular living individual, then applicant must submit the following:

- (1) A statement that the name "JÖRG HEINZ" identifies a living individual whose consent is of record. If the name represents that of a pseudonym, stage name, or nickname, applicant must include a statement that JÖRG HEINZ identifies the pseudonym/stage name/nickname of [specify actual name], a living individual whose consent is of record; and
- (2) A written consent, personally signed by the individual whose name or signature appears in the mark, authorizing applicant to register the name, pseudonym, stage name, nickname, or signature as a trademark and/or service mark with the USPTO (e.g., "I consent to the use and registration by Jörg Heinz GmbH & Co. of my name Jörg Heinz as a trademark and/or service mark with the USPTO").

TMEP §§813, 813.01(a), 1206.04(a); *see* 37 C.F.R. §2.61(b).

Failure to respond to this inquiry is a sufficient basis for refusing registration. *See In re Cheezwhse.com, Inc.*, 85 USPQ2d 1917, 1919 (TTAB 2008); *In re DTI P'ship LLP*, 67 USPQ2d 1699, 1701 (TTAB 2003); TMEP §814.

ENTITY CLARIFICATION

Applicant's business name includes the foreign business designation "GmbH & Co."; however, applicant set forth "company with limited liability" as the entity type in the application. This business designation is generally considered the equivalent of a "limited partnership in which, typically, the sole general partner is a limited liability company." *See* TMEP app. D. Therefore, applicant must clarify the entity type in

the application. *See* TMEP §803.03(i). Applicant may satisfy this requirement by amending the entity type to one of those immediately listed above from Appendix D of the *Trademark Manual of Examining Procedure* (TMEP) for this business designation, as appropriate. *See id.*

Alternatively, if applicant maintains that the entity type in the application properly identifies applicant's entity type, applicant must provide an explanation as to why the identified entity type is more similar to a "GmbH & Co." in this instance than to the entity types listed in TMEP Appendix D. *See id.*

ADVISORY: HIRING U.S. TRADEMARK COUNSEL

Because of the legal technicalities and strict deadlines involved in the USPTO application process, applicant may wish to hire a qualified U.S. attorney specializing in trademark matters to represent applicant in this process and provide legal advice. Although the undersigned trademark examining attorney is permitted to help an applicant understand the contents of an Office action as well as the application process in general, no USPTO attorney or staff is permitted to give an applicant legal advice or statements about an applicant's legal rights. RESPONSE GUIDELINES

For this application to proceed toward registration, applicant must explicitly address each refusal and/or requirement raised in this Office action. If the action includes a refusal, applicant may provide arguments and/or evidence as to why the refusal should be withdrawn and the mark should register. Applicant may also have other options for responding to a refusal and should consider such options carefully. To respond to requirements and certain refusal response options, applicant should set forth in writing the required changes or statements.

If applicant does not respond to this Office action within six months of the issue/mailling date, or responds by expressly abandoning the application, the application process will end, the trademark will fail to register, and the application fee will not be refunded. *See* 15 U.S.C. §1062(b); 37 C.F.R. §§2.65(a), 2.68(a), 2.209(a); TMEP §§405.04, 718.01, 718.02. Where the application has been abandoned for failure to respond to an Office action, applicant's only option would be to file a timely petition to revive the application, which, if granted, would allow the application to return to active status. *See* 37 C.F.R. §2.66; TMEP §1714. There is a \$100 fee for such petitions. *See* 37 C.F.R. §§2.6, 2.66(b)(1).

To expedite prosecution of the application, applicant is encouraged to file its response to this Office action online via the Trademark Electronic Application System (TEAS), which is available at <http://www.uspto.gov/trademarks/teas/index.jsp>. Further, although the trademark examining attorney may provide additional explanation pertaining to the refusal(s) and/or requirement(s) in this Office action, the trademark examining attorney may not provide legal advice or statements about applicant's rights. *See* TMEP §§705.02, 709.06.
