	Class 1- Nitrogen; acetates [chemicals]; chemical substances for preserving foodstuffs; transmission fluid; catalysts; oxygen; sulphuric acid; methyl-benzene; emollients for industrial purposes; benzene derivatives; fatty acids; solvents for varnishes; sulphur; acrylic resins, unprocessed; artificial resins, unprocessed; synthetic resins, unprocesses; caustic soda for industrial purposes; sodium salts [chemical preparations]; salts of alcaline metals; sulphides; toluol; industrial chemicals; refrigerating preparations; coolants for vehicle engines; cyanides [prussiates]; alkalies; caustic alkali; ethane; methyl ether; ethers; antifreeze; fluids for hydraulic circuits; brake fluid; power steering fluid; transmission fluid; chemical additives for oils; plasticizers.			





Class 3- Windscreen cleaning liquids.

Class 4- Dust-absorbing, wetting and binding compositions; fuel (including engine fuels) and combustible briquettes; gas and alcohols, not included in other classes; petroleum (raw or refined).

Class 16- Printed matter, including books, pamphlets, calendars, magazines (periodicals), newspapers, guidebooks; labels, not of textile; flags and pennants of paper; paper or plastic sachets and bags (wrappers, sleeves) used for packaging; plastic film for wrapping; paper and paper goods not included in other classes; training or teaching material (except apparatus); stationery items; office requisites (except furniture); jackets for documents; covers (stationery) (except those which are made of leather and imitation leather); photographs; decalcomanias; stickers (stationery items).

Class 35- Advertizing; market studies; business and statistical information; sale by auction; import-export agencies; document reproduction; commercial or industrial management assistance; projects (business management assistance); computerized file management; organization of exhibitions for commercial or advertizing purposes; business and statistical information on available jobs; business research; efficiency experts; sales promotion (for third parties); services relating to computer-aided sorting and processing of scientific research findings.

Class 36- Insurance underwriting; capital investment; credit bureaux; financial information; leasing of real estate; real estate management; mutual funds; charitable fund raising; banking; financial affairs, stock exchange quotations; brokerage; safe deposit services; factoring.

Class 37- Vehicle service stations; vehicle repair, vehicle maintenance, vehicle cleaning; road paving and road surfacing repair; installation, maintenance and repair of machinery, refrigerating apparatus, electrotechnical and electronic apparatus; building construction, repair and cleaning; communication system installation for buildings; rental of construction equipment; explosion work; quarrying services; mining extraction, including gas and petroleum extraction; well drilling; trench digging; pipeline construction and maintenance.
