5. **Grounds of the opposition:**

Pursuant to the institution of opposition proceedings against the trade mark in the above international registration, we issue this refusal letter. The grounds of the opposition are set out in the attached Statement(s) of Grounds filed together with Notice(s) of Opposition (Form(s) TM 11).

6. **Goods and/or services affected by the refusal:**

This refusal covers all the goods and/or services of the international registration.

7. **Information relating to subsequent procedure and deadline to observe:**

If the holder wishes to reply to the opposition, he must file a Counter-Statement together with Form HC6 for each Singapore trade mark number and the requisite fee for every class of goods or services in respect of which protection is opposed at the Intellectual Property Office of Singapore **within 4 months** from the date of this letter. At the same time, he must serve a copy of the Counter-Statement and Form HC6 on the opponent.

If the holder wishes to file for an extension of time to file his Counter-Statement(s), he may submit a request via Form HC3 to the Hearings and Mediation Group, Singapore. The holder must send a notice to any person or party who will be affected by such extension, requesting his consent. The holder's request for extension must be supported by such notice and such consent, if obtained.

The total extension of time for which the Registrar may allow to file the counter-statement shall not exceed 6 months from the date of this letter.

8. **Address for service in Singapore:**

If the holder does not have an address for service in Singapore, he must lodge one Form CM1 which should be filed together with his Counter-Statement(s). Each Form CM1 must contain the relevant Singapore trade mark number(s). Please note that where the request relates to more than one Singapore trade mark number, the total fee payable will be based on the number of Singapore trade mark indicated in the form. A copy of Form CM1 must also be served on the opponent.

STATEMENT OF GROUNDS OF OPPOSITION

We, **Sensi Vigne & Vini S.R.L.**, a company incorporated under the laws of Italy of Via Cerbaia, 107, Frazione Cerbaia, I-51035 Lamporecchio (PT), Italy (hereinafter referred to as "**the Opponent**") hereby give notice of our intention to oppose the registration of the Trade Mark Application Number **40201518075R** (hereinafter referred to as "**the Application**") in respect of the trade mark "**SENSE**" ("**the Applicant's Mark**") in Class 33 in the name of "**Vinprom Peshtera**" S.A. (hereinafter referred to as "**the Applicant**") for "Alcoholic beverages (except beers), including alcoholic energy drinks" ("**the Application Goods**") and published on Page 189 of the Singapore Trade Marks Journal No. 052/2015 dated 24 December 2015. The Application was filed on 18 June 2015.

The Grounds of Opposition are as follows:

1. The Opponent is a leading Italian wine producer established in 1890 and based in Lamporecchio, Italy. The Opponent's company name, **Sensi Vigne & Vini S.R.L.** bears the name of the founding family of the company and the fourth generation of the family continues to operate its wine business with its wines sold in leading countries in four continents, including in Singapore. The Opponent garners international awards for its wines annually, including the Berliner Wine Trophy (2011 to 2015), Decanter World Wine Awards (various years from 1999 to 2014) and International Wine Challenge (various years from 2002 to 2013). The Opponent's products range from sparkling wines to exclusive vintages that are available online and in retail stores in Singapore and are also sold in drinking and dining establishments, including wine bars and fine restaurants in Singapore.
2. The Opponent is the registered proprietor of Singapore TM **40201500867X (International Registration No. 1174331 "18 K SENSI"** in Class 33 for "Wines; aperitifs, sparkling wines, spirits and liqueurs; except beer" with a filing date of 29 October 2014 ("the

Opponent's Mark") which predates the Applicant's Mark and constitutes an "earlier trade mark" under Section 2 (1) of the Trade Marks Act (Cap. 332) ("the Act"). Registration of the Applicant's Mark should therefore be refused under Section 8(2)(b) of the Act because it is visually, aurally and phonetically very similar to the Opponent's Mark and is to be registered for goods or services similar to which the Opponent's Mark is protected and there exists a likelihood of confusion on the part of the public. In particular, especially among non-native English speakers in Singapore, the Applicant's Mark may be pronounced "sens-ee" which is aurally and phonetically identical with the distinctive portion of the Opponent's Mark "**SENSI**". Furthermore, the Applicant's Mark is strikingly similar to the Opponent's Mark visually in that the first four letters of the distinctive portion "**SENSI**" in the Opponent's Mark are identical and the final letter "E" is visually similar to the final letter "I" in the Opponent's Mark.


3. The Opponent's Mark is registered in respect of "Wines; aperitifs, sparkling wines, spirits and liqueurs; except beer" ("the Opponent's Goods") while the goods sought to be registered under the Applicant's Mark are "Alcoholic beverages (except beers), including alcoholic energy drinks" ("the Applicant's Goods") which overlap with and are in essence identical to the Opponent's Goods and will follow the identical trade channels as the Opponent's Goods. Registration of the Applicant's Mark is therefore likely to cause confusion on the part of public. In particular, the public may mistake the Applicant's Goods for the Opponent's Goods and/or believe that they originate from the same source as the Opponent's Goods.
4. Further and/or in the alternative, the Opponent is also the proprietor of the trade mark "**SENSI**" that is its company name and also a well known trade mark within the meaning of Section 2(1) of the Act, in that it constitutes an unregistered trade mark that is well known in Singapore and that belongs to a person who is a national of a Convention country, namely Italy, whether or not that person carries on business, or has any goodwill in Singapore ("the Opponent's **SENSI** Mark"). The Opponent's **SENSI** Mark has been used alone and as an element in combination marks that have been registered in internationally more particularly described in Annex A to denote the Opponent's Goods in Singapore and worldwide for many years and has become strongly associated with the Opponent.
5. The Applicant's Mark is aurally and phonetically identical or similar to the Opponent's **SENSI** Mark. In particular, especially among non-native English speakers in Singapore, the Applicant's Mark may be pronounced "sens-ee" which is aurally and phonetically identical with the Opponent's **SENSI** Mark. Furthermore, the Applicant's Mark is visually

strikingly similar to the Opponent's **SENSI** Mark in that the first four letters are identical and the final letter "E" is visually similar to the final letter "I" in the Opponent's **SENSI** Mark. The Application therefore offends Section 8(4)(a) read with 8(4)(b)(i) of the Act in that the Applicant's Mark is similar to the Opponent's **SENSI** Mark which is well known in Singapore and use of the Applicant's Mark in relation to the goods for which the Applicant's Mark is sought to be registered would indicate a connection between those goods and the Opponent and is likely to damage the interests of the Opponent.

7. Further and/or in the alternative, the Application offends Section 8(7)(a) and should not be registered as its use in Singapore is liable to be prevented by virtue of any rule of law (in particular, the law of passing off) protecting unregistered trade marks, namely the Opponent's **SENSI** Mark, used in the course of trade.
8. Registration and use of the Applicant's Mark by the Applicant would interfere with the trading activities and legitimate use by the Opponent of its aforementioned trade marks and would not be in the interests of the public and trade.
9. By reason of the matters stated above and by virtue of the law and in the exercise of the Registrar's discretion, the Opponent prays that the Application be refused and the opposition may be allowed with costs against the Applicant.



PROVISIONS OF SINGAPORE LAW

TRADE MARKS ACT (CHAPTER 332)

Section 2(1) Interpretation

"trade mark" means any sign capable of being represented graphically and which is capable of distinguishing goods or services dealt with or provided in the course of trade by a person from goods or services so dealt with or provided by any other person.

"earlier trade mark" means —

(a) a registered trade mark or an international trade mark (Singapore), the application for registration of which was made earlier than the trade mark in question, taking account (where appropriate) of the priorities claimed in respect of the trade marks; or

(b) a trade mark which, at the date of application for registration of the trade mark in question or (where appropriate) of the priority claimed in respect of the application, was a well known trade mark,

and includes a trade mark in respect of which an application for registration has been made and which, if registered, would be an earlier trade mark by virtue of paragraph (a) subject to its being so registered.

Section 8 Relative grounds for refusal of registration

(1) A trade mark shall not be registered if it is identical with an earlier trade mark and the goods or services for which the trade mark is sought to be registered are identical with the goods or services for which the earlier trade mark is protected.

(2) A trade mark shall not be registered if because —

(a) it is identical with an earlier trade mark and is to be registered for goods or services similar to those for which the earlier trade mark is protected; or

(b) it is similar to an earlier trade mark and is to be registered for goods or services identical with or similar to those for which the earlier trade mark is protected,
there exists a likelihood of confusion on the part of the public.

(4) Subject to subsection (5), where an application for registration of a trade mark is made on or after 1st July 2004, if the whole or an essential part of the trade mark is identical with or similar to an earlier trade mark, the later trade mark shall not be registered if —

(a) the earlier trade mark is well known in Singapore; and

(b) use of the later trade mark in relation to the goods or services for which the later trade mark is sought to be registered —

(i) would indicate a connection between those goods or services and the proprietor of the earlier trade mark, and is likely to damage the interests of the proprietor of the earlier trade mark; or

(ii) if the earlier trade mark is well known to the public at large in Singapore —

(A) would cause dilution in an unfair manner of the distinctive character of the earlier trade mark; or


(B) would take unfair advantage of the distinctive character of the earlier trade mark.

(5) A trade mark shall not be refused registration by virtue of subsection (4) if the application for the registration of the trade mark was filed before the earlier trade mark became well known in Singapore, unless it is shown that the application was made in bad faith.

(7) A trade mark shall not be registered if, or to the extent that, its use in Singapore is liable to be prevented —

(a) by virtue of any rule of law (in particular, the law of passing off) protecting an unregistered trade mark or other sign used in the course of trade.
